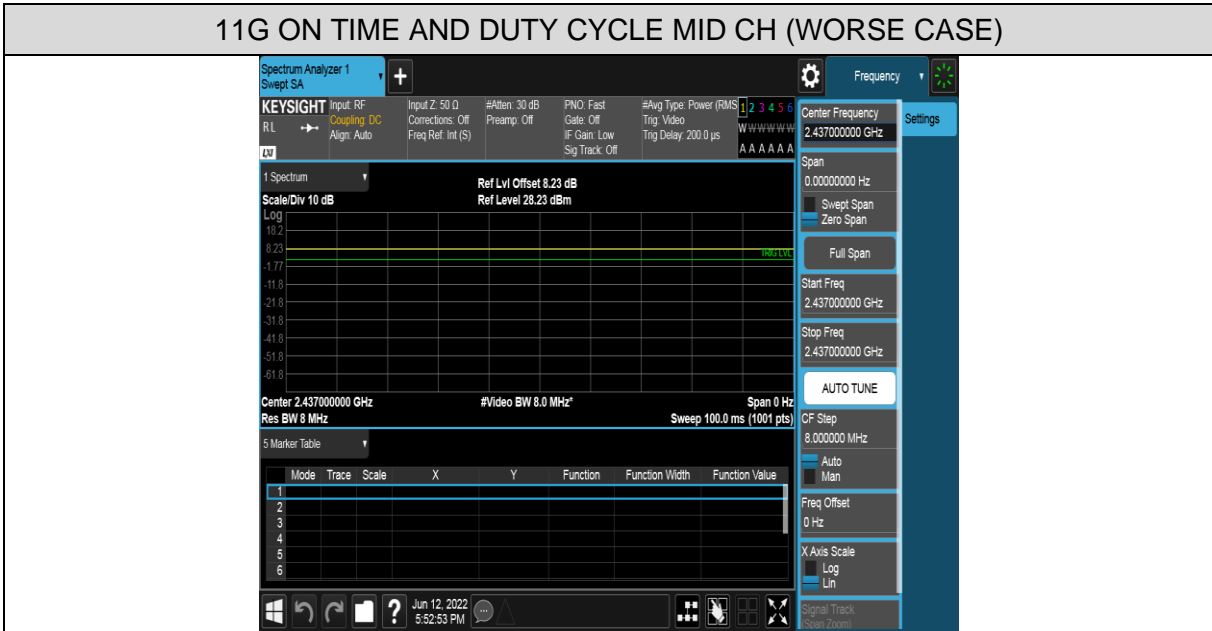


TEST GRAPHS
