2. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.10-2009, FCC CFR 47 Part 2, FCC CFR 47 Part 15.

3. FACILITIES AND ACCREDITATION

The test sites and measurement facilities used to collect data are located at 218 Maeyeong-ro, Yeongtong-gu, Suwon-si, Gyeonggi-do, 443-823, Korea. Line conducted emissions are measured only at the 218 address. The following table identifies which facilities were utilized for radiated emission measurements documented in this report. 4. CALIBRATION AND UNCERTAINTY

4.1. MEASURING INSTRUMENT CALIBRATION

The measuring equipment utilized to perform the tests documented in this report has been calibrated in accordance with the manufacturer's recommendations, and is traceable to recognized national standards.

4.2. SAMPLE CALCULATION

Where relevant, the following sample calculation is provided:

4.3. MEASUREMENT UNCERTAINTY

5.1. DESCRIPTION OF EUT

The EUT is a Bluetooth and DTS b/g/n Tablet.
This test report addresses the DTS (WLAN) operational mode.

5.2. MAXIMUM OUTPUT POWER

The transmitter has a maximum total conducted output power as follows:

5.3. DESCRIPTION OF AVAILABLE ANTENNAS

The radio utilizes an FPCB antennas, with a maximum gain of -0.19 dBi.

5.4. WORST-CASE CONFIGURATION AND MODE

Radiated emission and power line conducted emission were performed with the EUT set to transmit at the channel with highest output power as worst-case scenario.

The fundamental of the EUT was investigated in three orthogonal orientations X, Y and Z it was determined that X orientation was worst-case orientation; therefore, all final radiated testing was performed with the EUT in X orientation.

Based on the baseline scan, the worst-case data rates were:

802.11b mode: 1 Mbps
802.11g mode: 6 Mbps
802.11n HT20mode: MCS0

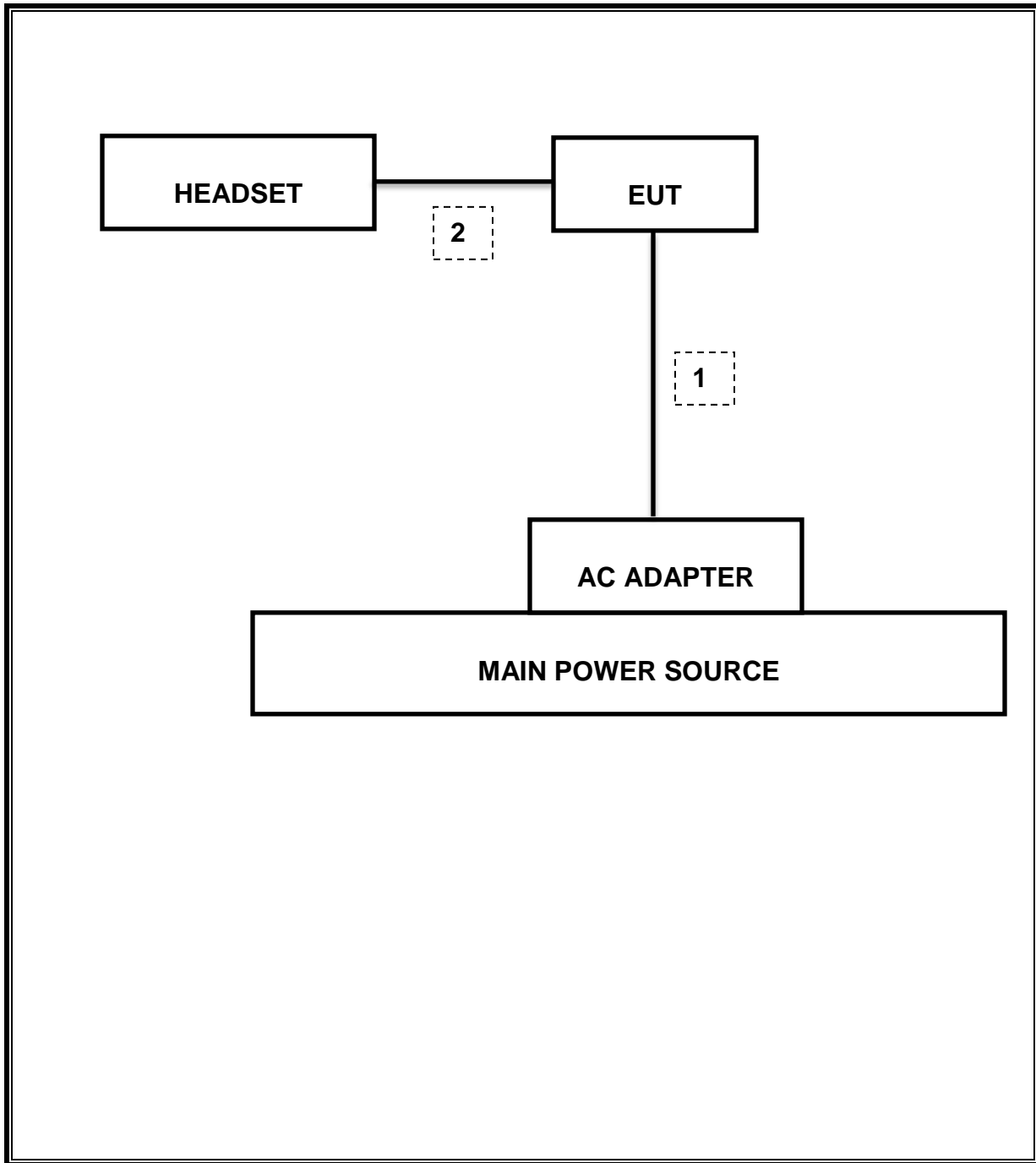

7. MEASUREMENT METHODS

KDB 558074 D01 DTS Meas Guidance v03r03: Measurement Procedure §9.2.3.1 AVGPM is used for power and §10.2 AVGPSD-1 is used for power spectral density.

Unwanted emissions within Restricted Bands are measured using traditional radiated procedures.

Band edge emissions within Restricted Bands are measured using RMS with duty cycle factor offset method.

9. SUMMARY TABLE

The FCC ID: A3LSMT560 shares the same enclosure and circuit board as FCC ID: A3LSMT561Y. The WLAN circuitry and layout, including antennas, are almost identical between the two units. The WLAN antennas and surrounding circuitry are the same between these two units.

After confirming through preliminary radiated emissions that the performance of the FCC ID: A3LSMT560 remains representative of FCC ID: A3LSMT561Y, test data for FCC ID: A3LSMT561Y is being submitted for this application to cover WLAN features.

The minimum 6 dB bandwidth shall be at least 500 kHz.

Reference to KDB 558074 D01 DTS Meas Guidance v03r03: The transmitter output is connected to a spectrum analyzer with the RBW set to 100kHz, the VBW $\geq 3 \times$ RBW, peak detector and max hold.

TEST PROCEDURE

The transmitter output is connected to a power meter.

The cable assembly insertion loss of 10.1 dB (including 10 dB pad and 0.1 dB cable) was entered as an offset in the power meter to allow for direct reading of power.

10.4. OUTPUT POWER

LIMITS

FCC §15.247

For systems using digital modulation in the 902–928 MHz, 2400–2483.5 MHz, and 5725–5850 MHz bands: 1 Watt, based on the use of antennas with directional gains that do not exceed 6 dBi. If transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

DIRECTIONAL ANTENNA GAIN

There is only one transmitter output therefore the directional gain is equal to the antenna gain.

10.6. OUT-OF-BAND EMISSIONS

LIMITS

FCC §15.247 (d)

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required.

TEST PROCEDURE

The transmitter output is connected to a spectrum analyzer with RBW = 100 kHz, VBW = 300 kHz, peak detector, and max hold. Measurements utilizing these settings are made of the in-band reference level, bandedge (where measurements to the general radiated limits will not be made) and out-of-band emissions.

TEST PROCEDURE

The EUT is placed on a non-conducting table 80 cm above the ground plane. The antenna to EUT distance is 3 meters.

For measurements below 1 GHz the resolution bandwidth is set to 100 kHz for peak detection measurements or 120 kHz for quasi-peak detection measurements. Peak detection is used unless otherwise noted as quasi-peak.

For measurements above 1 GHz the resolution bandwidth is set to 1 MHz; the video bandwidth is set to 3 MHz for peak measurements and add duty cycle factor for average measurements. Duty cycle factor= $10\log(1/x)$ For this sample B mode = 0dB (duty cycle >98%); G mode = 0.17dB; N mode = 0.28dB.

The spectrum from 30 MHz to 40 GHz is investigated with the transmitter set to the lowest, middle, and highest channels in each applicable band.

The frequency range of interest is monitored at a fixed antenna height and EUT azimuth. The EUT is rotated through 360 degrees to maximize emissions received. The antenna is scanned from 1 to 4 meters above the ground plane to further maximize the emission. Measurements are made with the antenna polarized in both the vertical and the horizontal positions.

TEST PROCEDURE

The EUT is placed on a non-conducting table 40 cm from the vertical ground plane and 80 cm above the horizontal ground plane. The EUT is configured in accordance with ANSI C63.4 2009.

The receiver is set to a resolution bandwidth of 9 kHz. Peak detection is used unless otherwise noted as quasi-peak or average.

Line conducted data is recorded for both NEUTRAL and HOT lines.
