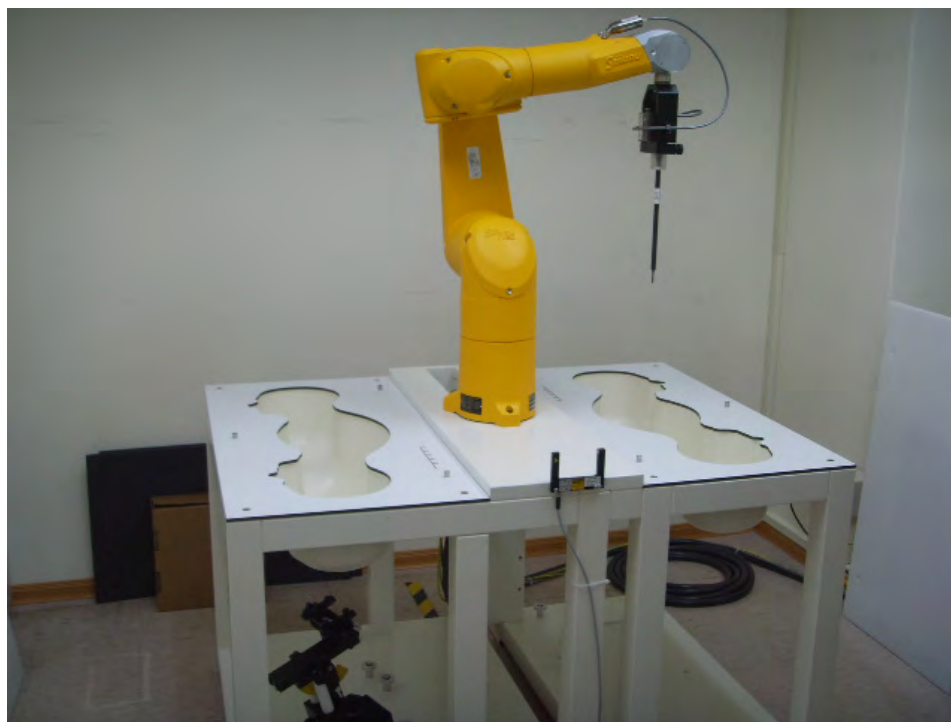


Fig.1 Photograph of the SAR measurement system

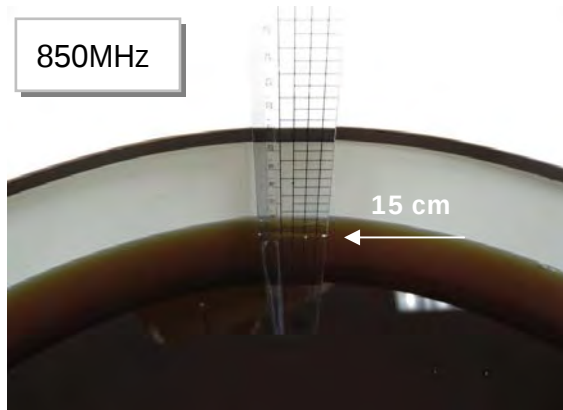

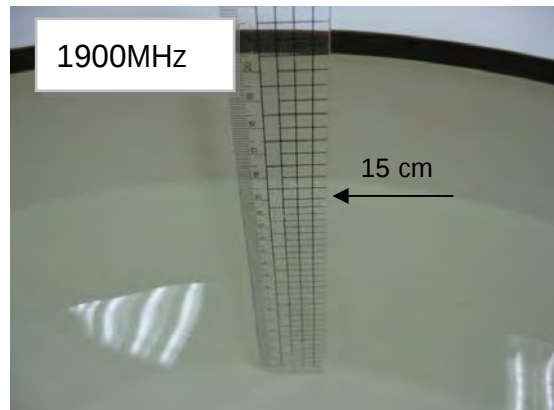

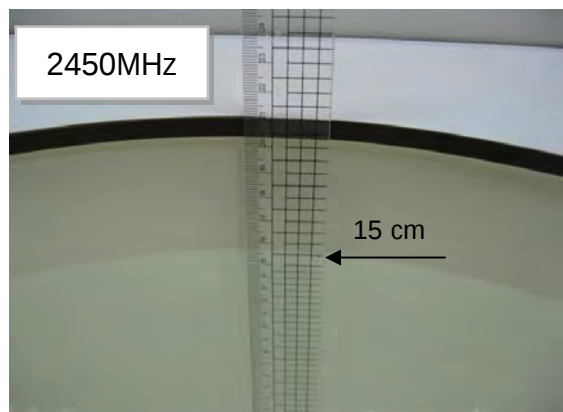

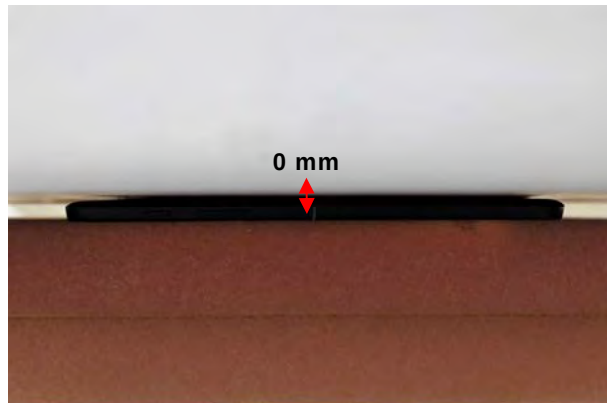


Fig.3 EUT Back side mode to flat phantom

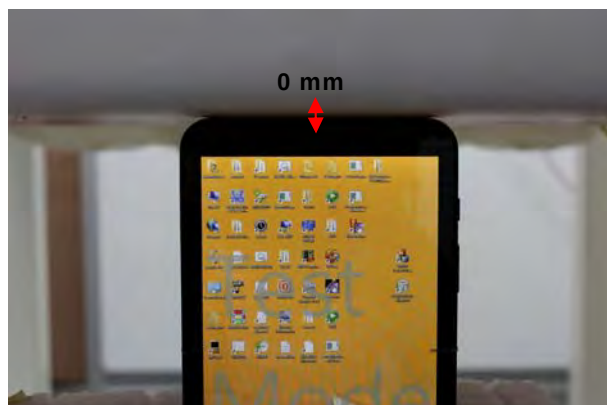
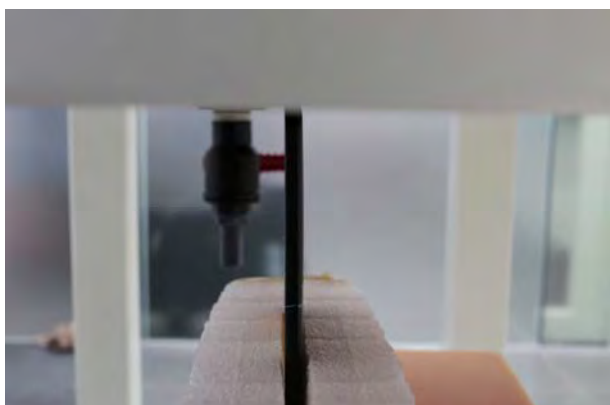


Fig.4 EUT Top side to flat phantom

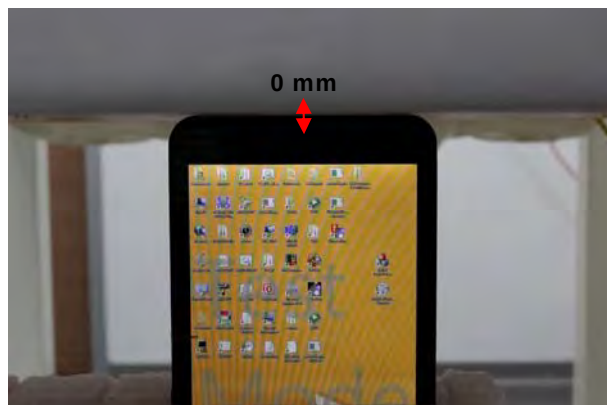
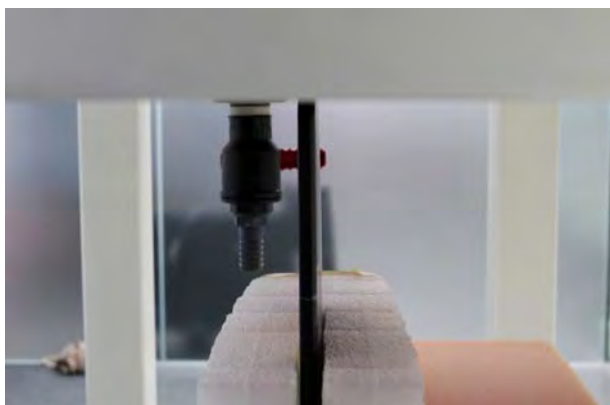


Fig.5 EUT Bottom side to flat phantom

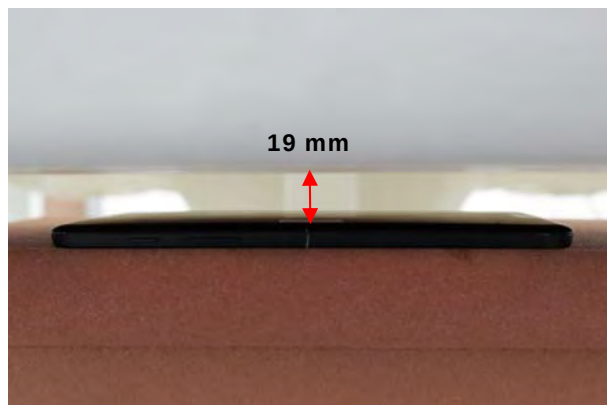


Fig.7 EUT Back side mode to flat phantom

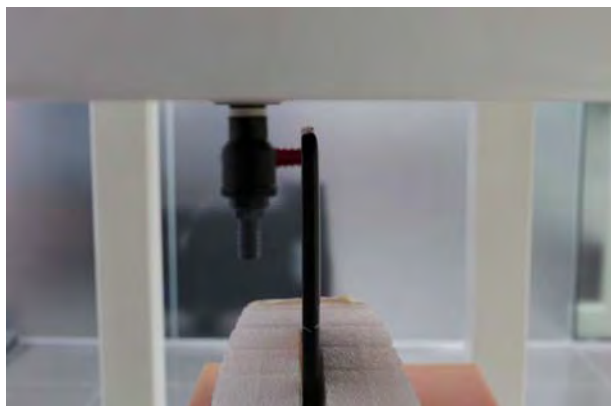


Fig.8 EUT Top side to flat phantom

Body - distance between flat phantom and EUT is 5 mm

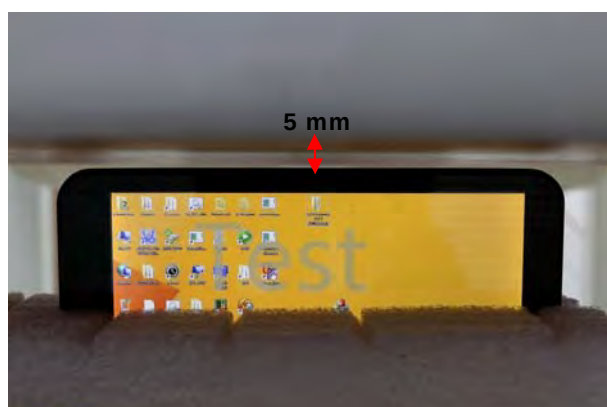


Fig.9 EUT Left side to flat phantom

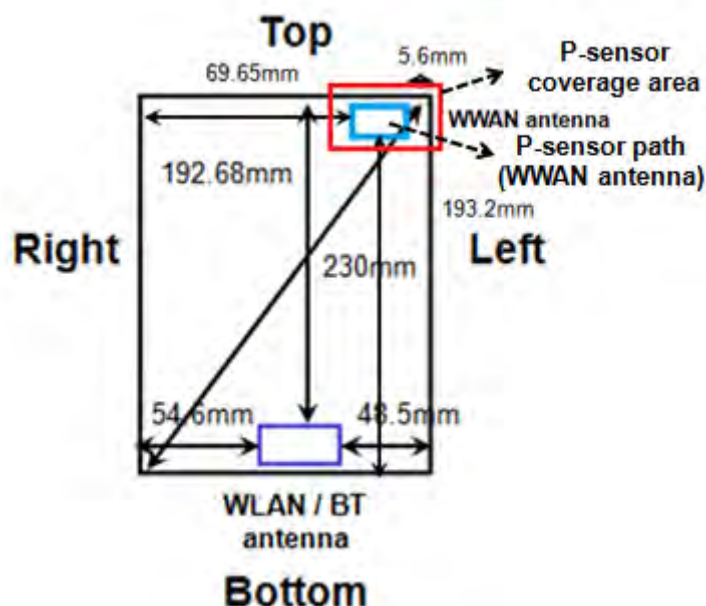


Fig.12 Antenna position of EUT (Back view)
