Based on Qualcomm's QSC6055 platform, the M570 provides an extra-long standby time and supports CDMA 1X 800/1900 MHz and AWS band, but only CDMA 1X 1900MHz test data in this report. Besides the basic voice, SMS, MMS, WAP, and BREW functions, the M570 also incorporates a camera, and supports applications such as Bluetooth, and weather forecast.

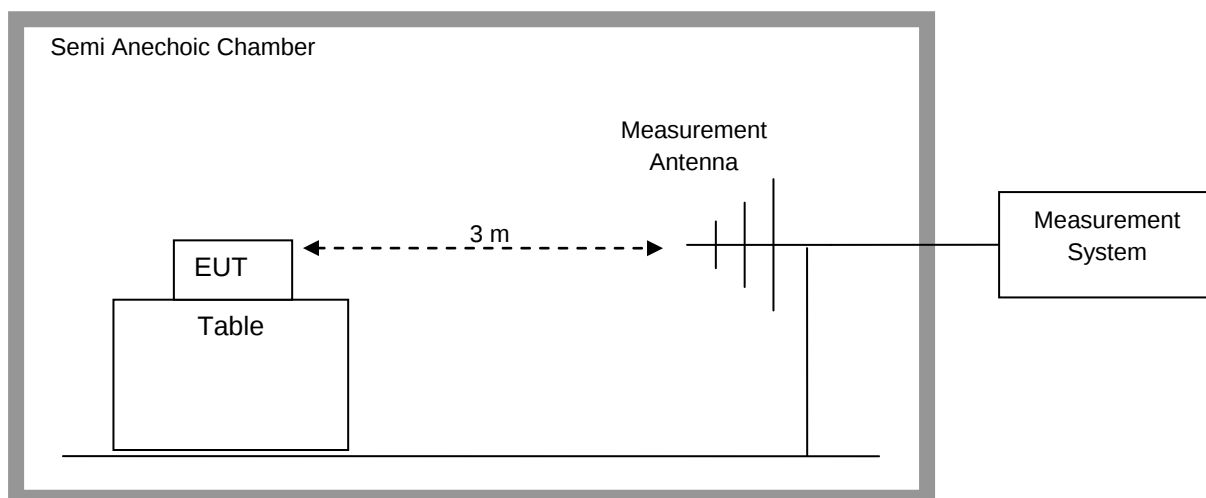

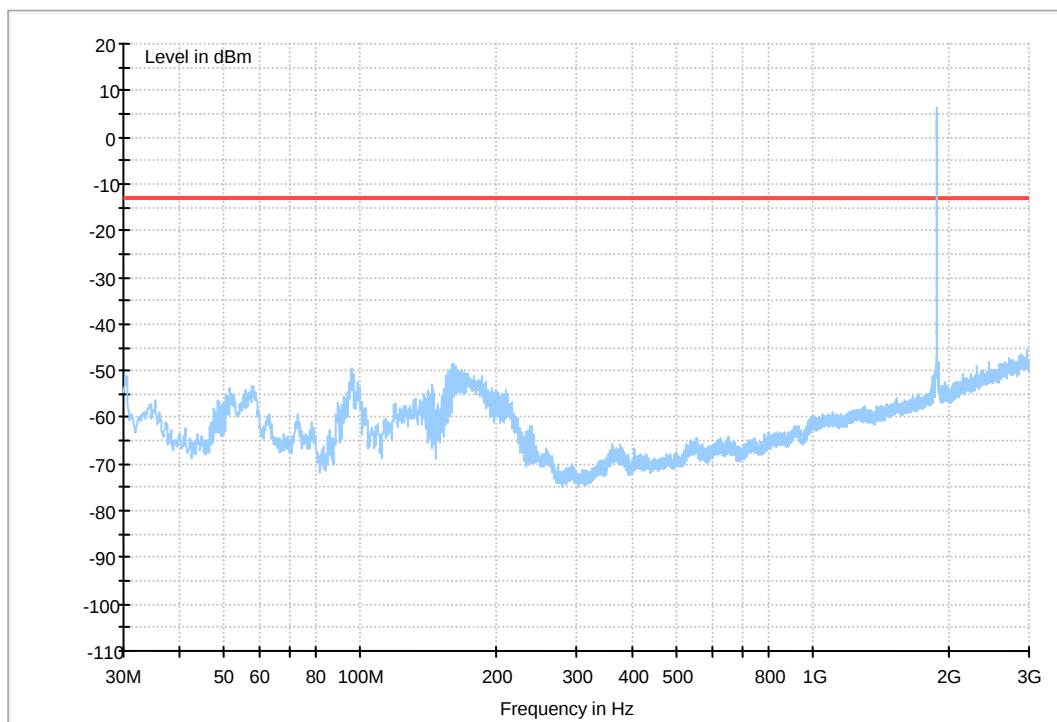
Radiated spurious emission

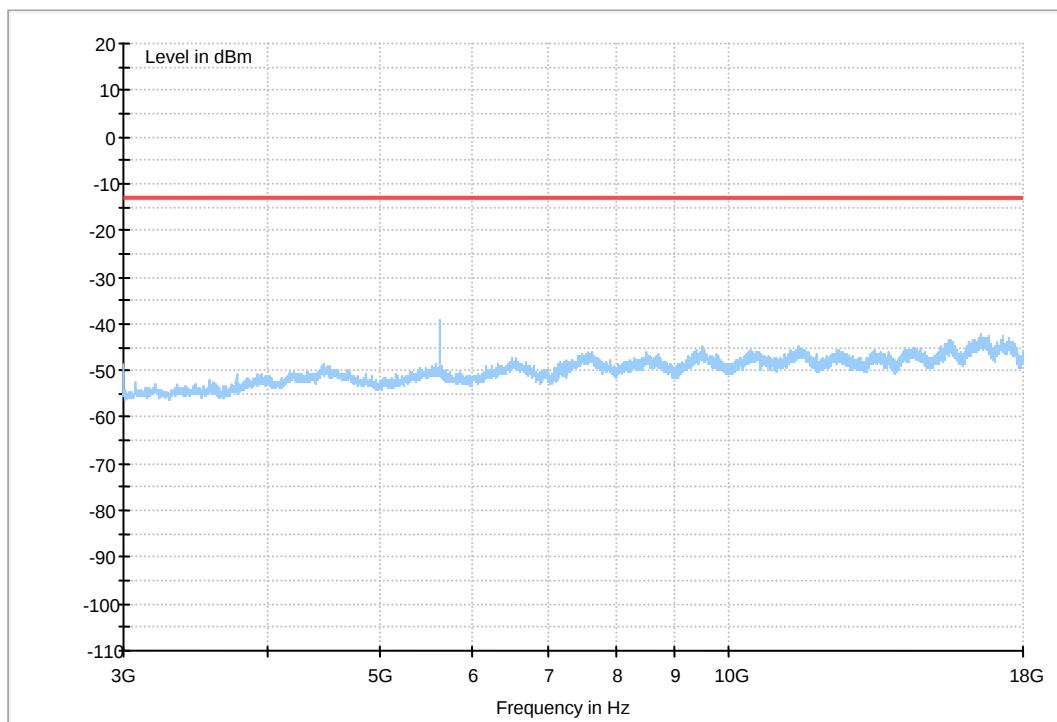

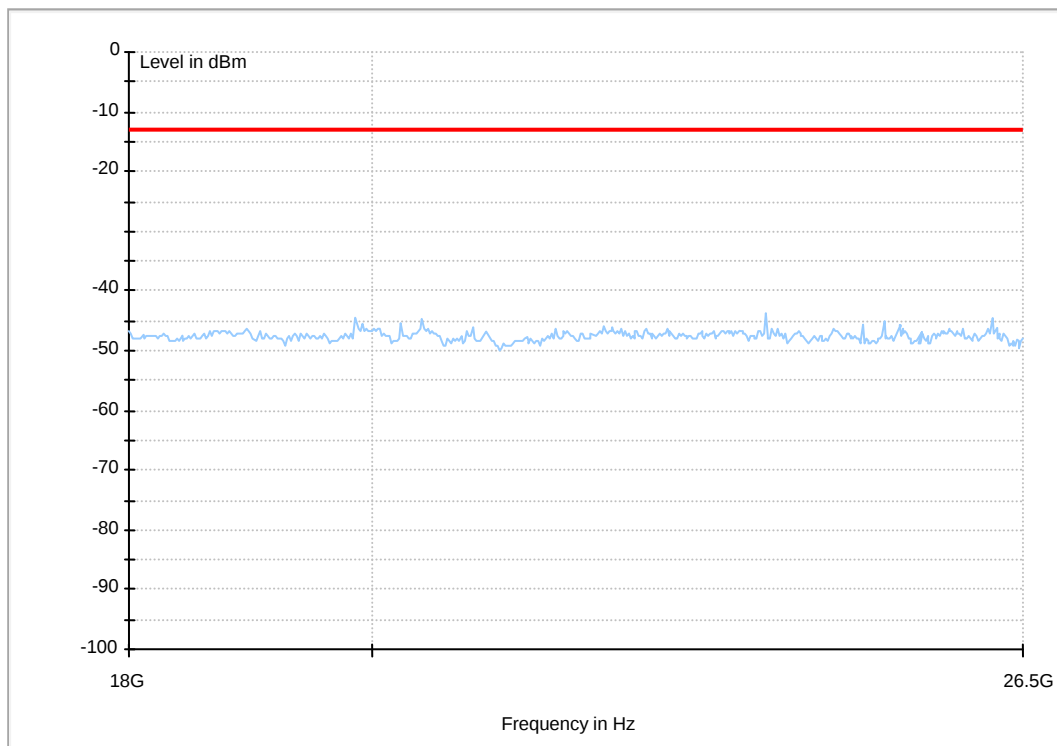
Traffic Mode (30MHz-3GHz)
