## **Appendix A:** FCC RF Exposure assessment result



#### General description of the device under evaluation

The device under evaluation consists of an electronic lock series with RFID Mifare (ISO 14443A standard based) and Bluetooth LE technology. Metallic enclosure.

According to the manufacturer, during its normal use, the separation distance between the radiating structures of the device and nearby users will be greater than 20 cm. In order to perform the assessment a conservative evaluation distance of 20 cm has been used.

The equipment specifications for each supported technology are shown in Table 1. Values corresponding to BTLE output power and gain have been declared by the manufacturer. Values corresponding to RFID output power have been measured and stated into DEKRA Testing and Certification, S.A.U. test report num. 72834RRF.008.

## **Appendix B:** FCC RF Exposure information



#### RF Exposure determination of exemption

According to FCC 47 CFR §1.1307 (b)(3) Determination of exemption:

- (i) For single RF sources (i.e., any single fixed RF source, mobile device, or portable device, as defined in paragraph (b)(2), a single RF source is exempt if:
  - (A) The available maximum time-averaged power is no more than 1 mW, regardless of separation distance. This exemption may not be used in conjunction with other exemption criteria other than those in paragraph (b)(3)(ii)(A) of this section. Medical implant devices may only use this exemption and that in paragraph (b)(3)(ii)(A);
  - (B) Or the available maximum time-averaged power or effective radiated power (ERP), whichever is greater, is less than or equal to the threshold Pth (mW) described in the following formula. This method shall only be used at separation distances (cm) from 0.5 centimeters to 40 centimeters and at frequencies from 0.3 GHz to 6 GHz (inclusive). Pth is given by:

$$P_{th} \text{ (mW)} = \begin{cases} ERP_{20 cm} (d/20 \text{ cm})^x & d \leq 20 \text{ cm} \\ ERP_{20 cm} & 20 \text{ cm} < d \leq 40 \text{ cm} \end{cases}$$

$$x = -\log_{10}\left(\frac{60}{ERP_{20~cm}\sqrt{f}}\right) \text{ and } f \text{ is in GHz;}$$

$$ERP_{20 cm} \text{ (mW)} = \begin{cases} 2040f & 0.3 \text{ GHz} \le f < 1.5 \text{ GHz} \\ 3060 & 1.5 \text{ GHz} \le f \le 6 \text{ GHz} \end{cases}$$

d = the separation distance (cm);

(C) Or using Table 1 and the minimum separation distance (R in meters) from the body of a nearby person for the frequency (f in MHz) at which the source operates, the ERP (watts) is no more than the calculated value prescribed for that frequency. For the exemption in Table 1 to apply, R must be at least  $\lambda/2\pi$ , where  $\lambda$ is the free-space operating wavelength in meters. If the ERP of a single RF source is not easily obtained, then the available maximum time-averaged power may be used in lieu of ERP if the physical dimensions of the radiating structure(s) do not exceed the electrical length of  $\lambda/4$  or if the antenna gain is less than that of a half-wave dipole (1.64 linear value).

(ii) For multiple RF sources: Multiple RF sources are exempt if:

(A) The available maximum time-averaged power of each source is no more than 1 mW and there is a separation distance of two centimeters between any portion of a radiating structure operating and the nearest portion of any other radiating structure in the same device, except if the sum of multiple sources is less than 1 mW during the time-averaging period, in which case they may be treated as a single source (separation is not required). This exemption may not be used in conjunction with other exemption criteria other than those is paragraph (b)(3)(i)(A) of this section. Medical implant devices may only use this exemption and that in paragraph (b)(3)(i)(A).

(B) in the case of fixed RF sources operating in the same time-averaging period, or of multiple mobile or portable RF sources within a device operating in the same time averaging period, if the sum of the fractional contributions to the applicable thresholds is less than or equal to 1 as indicated in the following equation.

a = number of fixed, mobile, or portable RF sources claiming exemption using paragraph (b)(3)(i)(B) of this section for Pth, including existing exempt transmitters and those being added.

b = number of fixed, mobile, or portable RF sources claiming exemption using paragraph (b)(3)(i)(C) of this section for Threshold ERP, including existing exempt transmitters and those being added.

c = number of existing fixed, mobile, or portable RF sources with known evaluation for the specified minimum distance including existing evaluated transmitters.

Pi = the available maximum time-averaged power or the ERP, whichever is greater, for fixed, mobile, or portable RF source i at a distance between 0.5 cm and 40 cm (inclusive).

Pth,i = the exemption threshold power (Pth) according to paragraph (b)(3)(i)(B) of this section for fixed, mobile, or portable RF source i.

ERPj = the ERP of fixed, mobile, or portable RF source j.

ERPth,j = exemption threshold ERP for fixed, mobile, or portable RF source j, at a distance of at least  $\lambda/2\pi$  according to the applicable formula of paragraph (b)(3)(i)(C) of this section.

Evaluated,k = the maximum reported SAR or MPE of fixed, mobile, or portable RF source k either in the device or at the transmitter site from an existing evaluation at the location of exposure.

Exposure Limit,k = either the general population/uncontrolled maximum permissible exposure (MPE) or specific absorption rate (SAR) limit for each fixed, mobile, or portable RF source k, as applicable from §1.1310 of this chapter.

Each supported transmission technology will be evaluated to determine if it is in compliance with limits for Maximum Permissible Exposure (MPE) to radiofrequency electromagnetic fields.

In order to perform the assessment, the following equations have been used for the calculations; these equations are accurate in the far-field of an antenna and will over-predict power density in the near field, where they could be used for making a "worst-case" or conservative prediction:

#### NFC/RFID output power calculation

Output power values corresponding to RFID technology shown in Table 1 of "General description of the device under evaluation" section are calculated from maximum measured field strength values stated into DEKRA Testing and Certification test report num. 72834RRF.008 (see table below) following the calculation described below:

According to ANSI C63.10-2013, section 6.4.4.2:

If the Maximum E-field strength measured is at a distance greater than  $\lambda/2\pi$ , then extrapolation to the limit distance shall be calculated using the following equation:

$$FS_{\text{limit}} = FS_{\text{max}} - 20\log\left(\frac{d_{\text{limit}}}{d_{\text{measure}}}\right)$$

If both the Maximum E-field strength measured and the limit distance are equal to or closer to the EUT than  $\lambda/2\pi$  the extrapolation to the limit distance shall be calculated using the following equation:

$$FS_{\text{limit}} = FS_{\text{max}} - 40\log\left(\frac{d_{\text{limit}}}{d_{\text{measure}}}\right)$$

FS limit is the calculation of field strength at the limit distance, expressed in dBµV/m

FS max is the measured field strength, expressed in dBµV/m d measured is the distance of the measurement point from the EUT is the reference distance or the distance of the  $\lambda/2\pi$  point. d limit

As a result of this calculation, equivalent output power (dBµV/m) at minimum distance of use between user and device is obtained, which is converted to dBm units applying the calculation shown in ANSI C63.10-2013, section J.3:
