FCC requirement: Systems operating under the provisions of this section shall be operated in a manner that ensures that the public is not exposed to radio frequency energy level in excess limit for maximum permissible exposure. In accordance with 47 CFR FCC Part 2 Subpart J, section 2.1091 this device has been defined as a mobile device whereby a distance of 20cm normally can be maintained between the user and the device.

Power Density: $S_{(mW/cm^2)} = PG/4\pi R^2$ or $EIRP/4\pi R^2$

Where:

S = power density (mW/cm²)

P = power input to the antenna (mW)

G = power gain of the antenna in the direction of interest relative to an isotropic radiator

R = distance to the center of radiation of the antenna (cm)

The nominal maximum conducted output power specified:

2.4GHz FHSS: 20.00 dBm Wi-Fi 802.11 b/g/n: 23.00 dBm

From the peak RF output power, the minimum mobile separation distance, d=20 cm, as well as the antenna gain (Max. 0.0 dBi for 2.4GHz FHSS, 0.0 dBi for Wi-Fi 802.11 b/g/n), the RF power density can be calculated as below:

For 2.4GHz FHSS: $S_{(mW/cm^2)} = PG/4\pi R^2 = 0.020 \text{ mW/cm}^2$ For Wi-Fi 802.11 b/g/n: $S_{(mW/cm^2)} = PG/4\pi R^2 = 0.040 \text{ mW/cm}^2$

Exemption from Routine Evaluation Limits – RF Exposure Evaluation

RF exposure evaluation is required if the separation distance between the user and/or bystander and the device's radiating element is greater than 20 cm, except when the device operates as follows:

at or above 300 MHz and below 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 1.31 x 10^{-2} $f^{0.6834}$ W (adjusted for tune-up tolerance), where f is in MHz;

- RF exposure evaluation exempted power for 2.4GHz FHSS: 2.670 W
- RF exposure evaluation exempted power for Wi-Fi 802.11 b/g/n: 2.684 W

The nominal maximum conducted output power specified:

2.4GHz FHSS: 20.00 dBm Wi-Fi 802.11 b/g/n: 23.00 dBm

Antenna Gain: 0.0 dBi for Wi-Fi 802.11 b/g/n

The Max. e.i.r.p. for 2.4GHz FHSS: 20.00 dBm = 0.100 W The Max. e.i.r.p. for Wi-Fi 802.11 b/g/n: 23.00 dBm = 0.200 W

Both e.i.r.p. for 2.4GHz FHSS and Wi-Fi 802.11 b/g/n are less than the RF exposure evaluation exempted power. So RF exposure evaluation is not required.
