**Re: Request for a Permit to Deliver Programming
To Foreign Broadcast Station**

Dear Sir or Madam:

Warner Bros. Domestic Television Distribution ("Warner Bros."), 4000 Warner Blvd., Burbank, CA 91522, a division of Warner Bros. Television Distribution Inc., hereby respectfully requests, by informal application and pursuant to Section 325(c) of the Communications Act of 1934, as amended, 47 U.S.C. § 325(c), and Section 73.3545 of the Commission's rules, 47 C.F.R. § 73.3545, authority to transmit English-language entertainment programming of a continuing nature, via satellite, to Mexican television station XETV, Tijuana, Mexico ("XETV" or "Station").

Section 73.3545 provides that an applicant for a permit to deliver programming to a foreign broadcast station may submit an informal application under Section 325(c) (in letter form) in lieu of the otherwise required FCC Form 308 if the applicant holds a valid radio or television broadcast station license or construction permit. The applicant, Warner Bros., is an indirect subsidiary of Time Warner, Inc., which through other subsidiaries holds the license for WTBS(TV), Atlanta, Georgia.

Warner Bros. has licensed the broadcast rights to the following English-language entertainment programming series to XETV:¹

¹ If a series is listed as "not currently on air," either XETV's rights to broadcast that series have not yet commenced, or for other reasons the series is not on the Station's current programming schedule for the Fourth Quarter 2003.

In addition, Warner Bros. has licensed two theatrical film packages to XETV. Volume 32 features 19 motion pictures, each of which XETV may air once during that film's individual three-week window. Volume 34 features 27 motion pictures, each of which XETV may air twice during that film's three-week window. Warner Bros. proposes to deliver to XETV, via satellite, the programs listed in the above chart, the Volume 32 and Volume 34 movies whose release windows have not yet passed, and any other future English-language entertainment programming that the Station licenses from Warner Bros.

The currently licensed programming will originate at the facilities of Global Digital Media Exchange, 5432 West 102nd Street, Los Angeles, California 90045, and will be delivered via satellite. No interconnecting common carriers will be involved in the delivery of programming.

Station XETV, Tijuana, B.C., is a commercial television station licensed to Radio Televisión, S.A. de C.V. It operates in analog mode on Channel 6 at 99.25 kilowatts maximum visual effective radiated power ("ERP") and in digital mode on Channel 23 at 402.8 kilowatts ERP from transmission facilities located in Tijuana. XETV is the FOX affiliate serving the San Diego market and broadcasts in the English language.

Warner Bros. has granted XETV the right to broadcast the programming listed above in the San Diego market, but has no other legal relationship with the Station. Copies of the

program license agreements between Warner Bros. and XETV, with renewals where applicable, are enclosed.²

In sum, Warner Bros. seeks authority to deliver theatrical films, situation comedies, courtroom reality programs, game shows, music and variety shows, and any other form of English-language entertainment programming to XETV.

Also enclosed are a completed FCC Form 159, a check in the amount of \$80.00 payable to the Federal Communications Commission to cover the filing fee, and a certification that no party to the application is subject to a denial of FCC benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. § 862.
