We will take the following steps to update the studio location for Uniradio's 4 stations.

The following steps are (1) we need Uniradio Corp to submit in writing their request to notify us of the location change of their studio; (2) FCC/I will make a notation in IBFS (3) scan the applicant's letter into IBFS (4) edit the IBFS record to reflect the new studio location and (5) print copies of the new authorization for each of the applicant hard files)

Our proposed steps are based on our analysis that Uniradio's request is not a substantial change (studio location change) as it does not play a major role in our decision to grant or deny an authorization, therefore, we do not feel that a Public Notice is warranted.

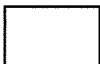
