Martha M. Barba is the sole owner of the noncommercial permit for XHLNC(FM), licensed to Tecate/Tijuana, Mexico. Neither the applicant nor any other party to this application has any interest in, or connection with, any other AM, FM or TV broadcast station (either domestic or foreign), or any application pending before the Commission.

Martha M. Barba is President and a board member of the applicant. She is also the sole owner and licensee of XHLNC(FM).

## XLNC1, Inc. Form 308 – Exhibit 3 Question 18(a) -- Frequency of Programming

The applicant intends to transmit programming to XHLNC approximately 80 hours per month. However, this figure may increase during the station's fundraising campaigns, which occur four times per year and last 7 days each. During each of those campaigns, the Applicant may transmit as much as 120 hours of programming per month from the United States.

Notwithstanding the foregoing, Applicant hereby requests authority to transmit programming from the United Sates on a 24/7 basis (24 hours per day/7 days per week), should it choose to do so in the future. Although not currently planned, receipt of this authority would avoid the need for Applicant to have to go back to the Commission to amend this request and the subsequent authority granted by the Commission pursuant to this request. As the Commission is aware, this application has now been submitted three times over the past seven years. Applicant hopes to avoid beginning this process all over again by receiving 24/7 authority now.
