

This letter responds to a request from staff of the FCC's International Bureau that NBC Telemundo License LLC ("Licensee") amend the application filed on April 13, 2015, on Form 308 for extension of Licensee's existing Section 325(c) permit to deliver programming to a foreign broadcast station. Licensee hereby amends the application to provide the following information:

1. Question 18(a) is hereby amended to confirm that the program deliveries to Station XHAS-TV are regularly scheduled, totaling approximately 118 hours per week (17 hours each weekday and 16.5 hours on Saturday and Sunday).

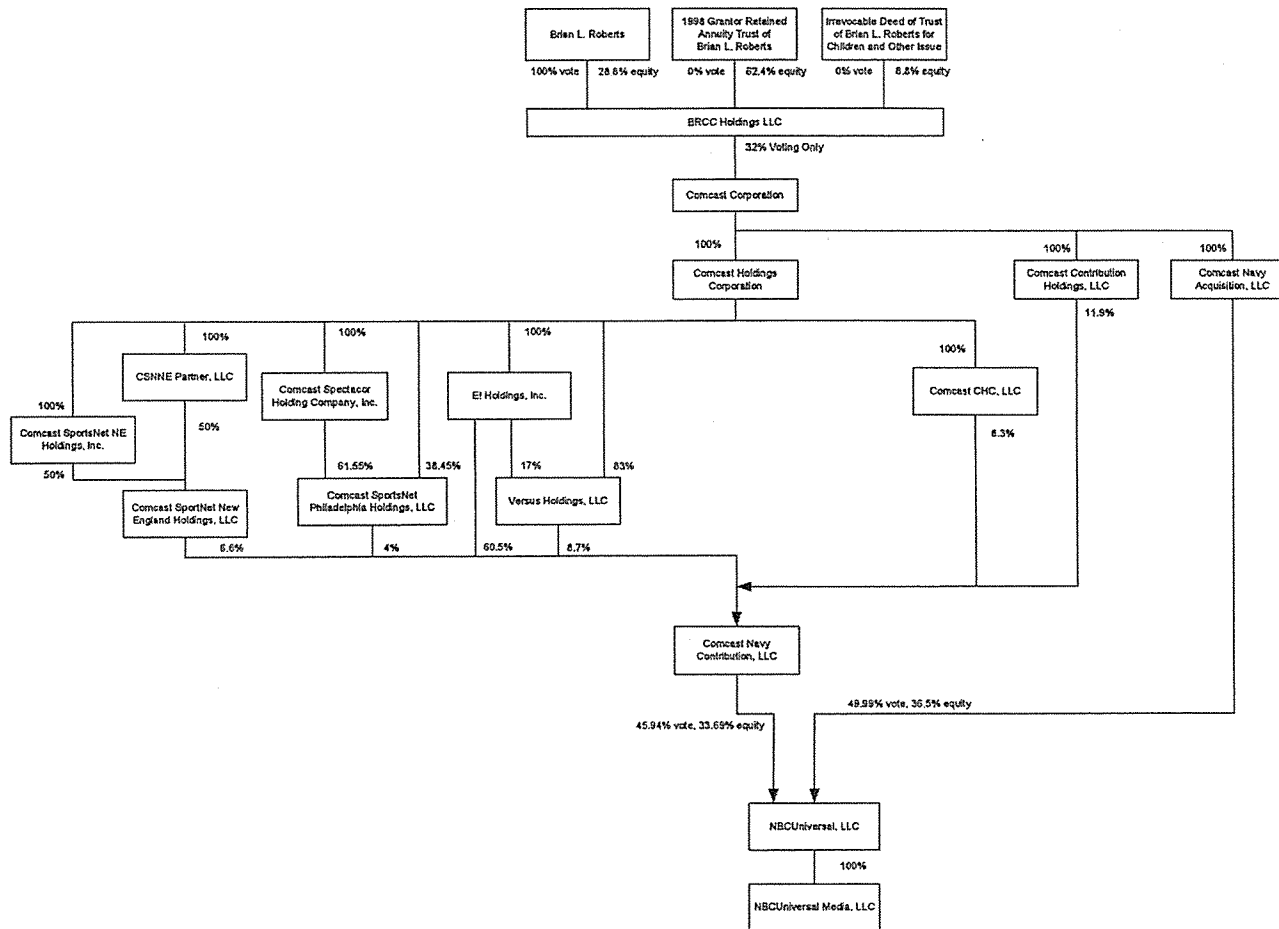

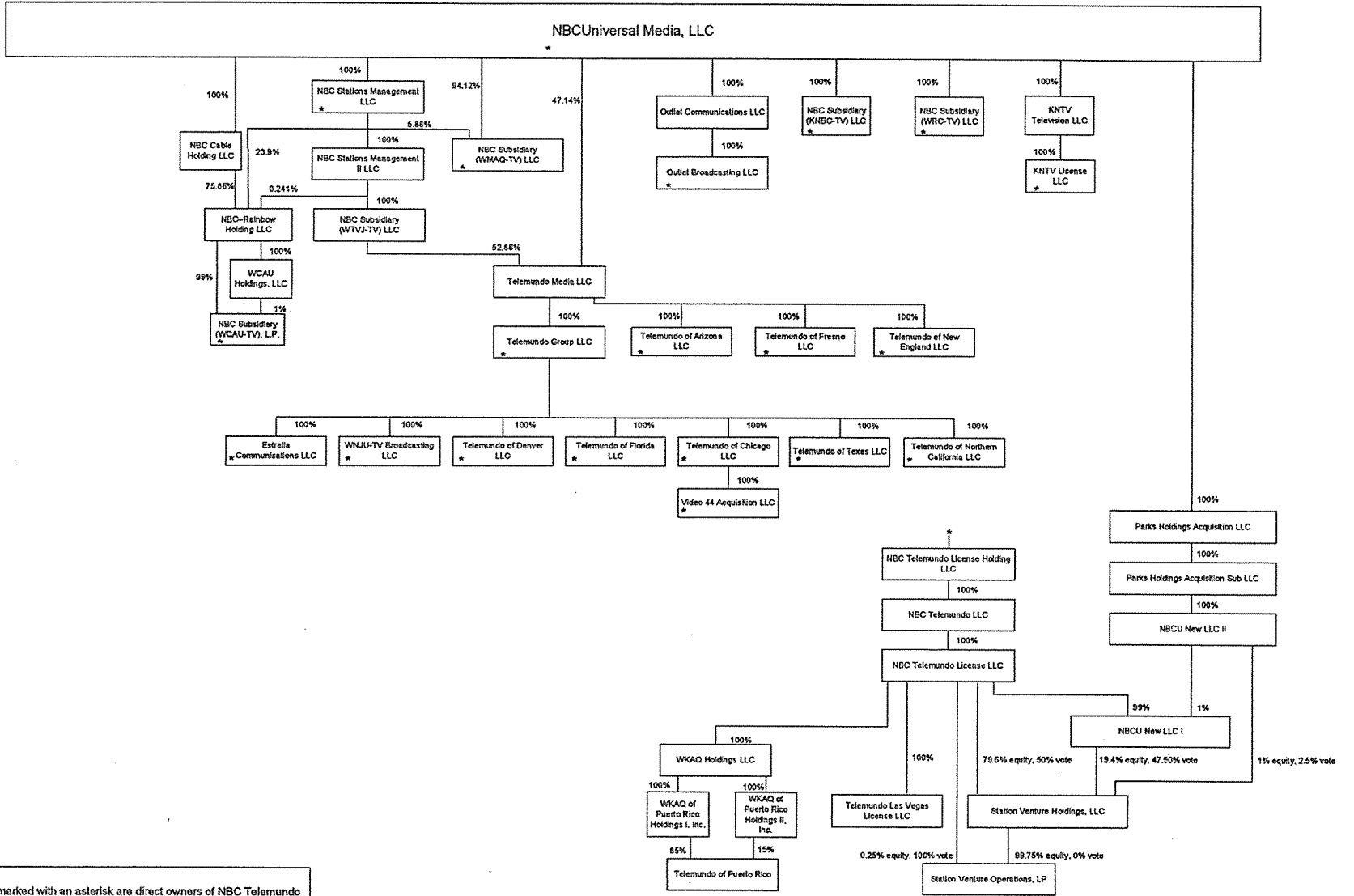

DESCRIPTION OF RELATIONSHIP

AND

NATURE OF PROGRAMMING

On June 10, 2010, the Federal Communications Commission granted NBC Telemundo License Co. authority to deliver program material from the Telemundo Network to Mexican Television Broadcast Station, XHAS-TV, Tijuana, Baja California, Mexico (the "Station"), the signals of which are consistently received within the United States, in accordance with requirements under Section 325(c) of the Communications Act of 1934, as amended. (File Number 325-NEW-20100422-00003.) The Station is licensed to a Mexican Company, Tele Nacional S. de R.L. de C.V., and is operated by U.S. company Entravision Communications Company, L.L.C., pursuant to a time brokerage agreement.

The Station functions as a Telemundo Network affiliate, primarily carrying Telemundo Network programming (along with some local programming). The Telemundo Network is a full service Spanish language programmer, providing a full slate of news, informational and entertainment programming, as well as Spanish-language children's informational and educational programming, meeting the requirements of the Children's Television Act, as implemented by the Commission and producing and distributing programming that is recognized to serve the public interest. The Commission has previously determined that the Station is eligible to receive programming from U.S. entities and has concluded that the Station is operating within its operating parameters and does not pose a risk of harmful interference.

Grant of this application will allow the Telemundo Network to maintain its coverage in the San Diego-Tijuana area, including its news coverage, and to better serve the needs of the Hispanic community.

Ladies and Gentlemen:

Reference is made to the Affiliation Agreement dated July 1, 2007, between Telemundo Network Group LLC ("Telemundo") and Entravision Communications Company, L.L.C. ("ECC") for the Telemundo network affiliation of Channel 33, XHAS in Tijuana, Baja California, Mexico (the "Station") in the designed market area (as defined by Nielsen Media Research, Inc.) of San Diego, California (the "DMA") (the "Agreement").

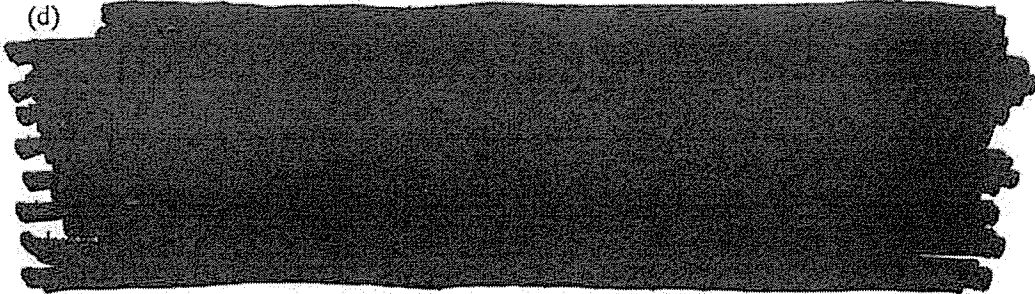
The parties agree to amend the agreement as follows:

1. Term: The parties agree to extend the Agreement for an additional five (5) years through June 30, 2017 (the "Term").
2. Delivery and Distribution: Paragraph 4 (d) shall be added as follows:

(d) Station shall broadcast the Programming on the primary channel of the Station and in the same technical format provided by Telemundo, i.e. in high definition where applicable, give the highest statistical multiplex priority to the Content Supply and shall dedicate an average of 12 Mbps data capacity on its digital broadcast spectrum to broadcasting the Content Supply. Lower bit rates are acceptable in systems employing statistical multiplexing provided the Telemundo lower bit rate is set at 4 or more and the maximum bit rate is set to 14 Mbps or more. In all cases, the video, picture and sound of the Content Supply delivered to the DMA shall be of high quality.

3. Cable Carriage and Retransmission Consent: Paragraph 16(d) shall be added as follows:

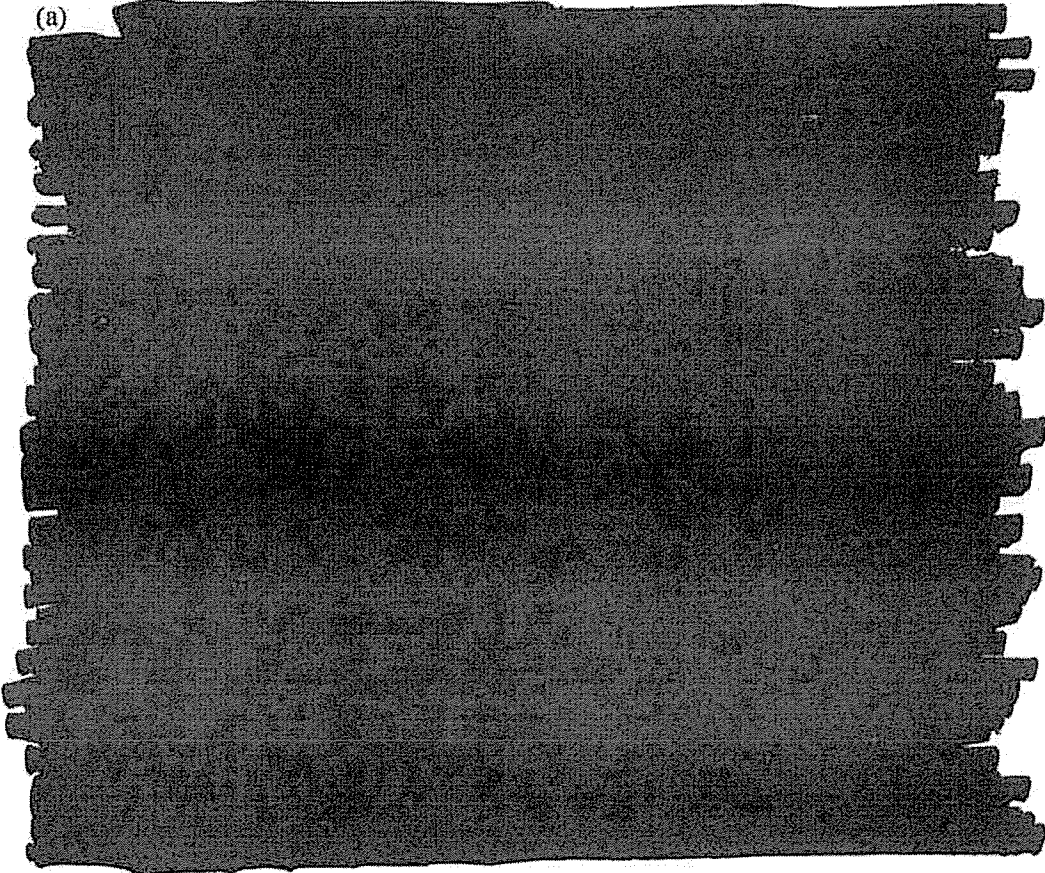
