On behalf of Blue Mountain Networks LLC ("Blue Mountain Networks"), please be advised that the transfer of control of Axxis Communication, Inc. ("Axxis" or the "Licensee") from Dan Bubb to Blue Mountain Networks was consummated on December 13, 2019.

The application for this transaction noted that Blue Mountain Networks continued to finalize its ownership structure and that the ownership interests listed in the application could fluctuate slightly and additional investors might be identified. Blue Mountain Networks has finalized its ownership structure. To ensure the Commission's records are complete, Blue Mountain Networks updates its ownership information for the following individuals and entities, all of whom were identified in the application as holding an indirect 10 percent or greater ownership interest in Axxis post-closing:

- Blue Mountain Holdings LLC ("Blue Mountain Holdings") holds 98 percent of Blue Mountain Networks.
- Sardar Faisal Nisar holds approximately 27 percent of Blue Mountain Holdings and owns ZRF Partners LLC.
- Saba N. Nisar 2012 Spousal Lifetime Access Trust holds approximately 22 percent of Blue Mountain Holdings.


