Radiate Holdings, L.P. (“Radiate”), hereby respectfully notifies the Federal Communications Commission (“Commission”) that the transaction described in the above-referenced applications was consummated on January 22, 2021, resulting in the substantive transfer of control of Digital West Networks, Inc. (“Digital West Networks”), Norcast Communications Corporation (“Norcast”), and Blue Rooster Telecom, Inc. (“Blue Rooster” and, together with Digital West Networks and Norcast, the “Digital West Licensees”) to Radiate.

Pursuant to 47 C.F.R. §63.24(e)(4), Radiate notes that the international application addressed the substantive transfer of control of authorizations initially granted to Norcast in IBFS File No. ITC-214-20030410-00183 and to Blue Rooster in IBFS File No. ITC-214-20100317-00112. The international applications were approved effective October 23, 2020 (public notice
