Dear Ms. Stein:

You filed a series of applications with the Federal Communications Commission, and upon our review of them, we found they were incomplete. We attempted to contact you regarding your applications at the phone number and email addresses listed on your applications, but our voice message was not returned and our emails were returned as undeliverable.¹

Therefore, the following applications have been dismissed by the Telecommunications and Analysis Division, International Bureau, pursuant to Sections 1.746 and 1.10014 of the Commission's rules, 47 CFR §§ 1.746 and 1.10014, for being defective:

- DNC-NEW-20180415-00001 (filed April 15, 2018)
- DNC-NEW-20180415-00002 (filed April 15, 2018)
- SPC-NEW-20180415-00001 (filed April 15, 2018)

These dismissals are without prejudice to re-filing the applications in accordance with the Commission's rules, 47 CFR §§ 1.10006, 1.10007, 1.10014.

Further, you filed an application for an Accounting Rate Change (ARC) (ARC-PDR-20180415-00001) on April 15, 2018. The Commission no longer has a requirement to file accounting rate change applications, and we will delete your application in the International Bureau Filing System (IBFS). The


