Question 16

Pursuant to Section 63.10 of the Commission's rules, 47 C.F.R. Sect. 63.10, the above-listed AT&T international carrier affiliates qualify for continued non-dominant classification on the route between the U.S. and Canada because their new affiliate in Canada, BSLD, has no market power on the foreign end of this route. BSLD has market shares under 50 percent in all relevant markets on the foreign end of the U.S.-Canada route, including the international transport and local access markets in Canada. Additionally, BSLD is not listed on the Commission's List of Foreign Telecommunications Carriers that are Presumed to Possess Market Power in Foreign Telecommunications Markets. See Public Notice, The International Bureau Revises and Reissues the Commission's List of Foreign Telecommunications Carriers that are Presumed to Possess Market Power in Foreign Telecommunications Markets, Jan. 26, 2007, http://hraunfoss.fcc.gov/edocs_public/attachmatch/DA-07-233A1.pdf. Accordingly, pursuant to Section 63.10(a)(3), the above-listed AT&T entities are presumptively classified as non-dominant on this route.
