## ATTACHMENT 1

### AT&T Mobility LLC Foreign Carrier Affiliation Notification

Pursuant to Section 63.11(b)-(c) of the Commission's rules, AT&T Mobility LLC (f/k/a Cingular Wireless LLC) hereby submits on behalf of itself and its subsidiaries that hold international Section 214 authorizations (collectively referred to as "AT&T Mobility" or "the Applicants")<sup>1</sup> a foreign carrier affiliation notification ("FCN") for an the affiliation with BellSouth Long Distance, Inc. ("BSLD"), which holds a Class B license issued by the Canadian Radio-Television and Telecommunications Commission for the provision of international telecommunications services in Canada on a resale basis. BSLD is a wholly owned subsidiary of BellSouth Corporation ("BellSouth"), which became a wholly owned subsidiary of AT&T Inc. on December 29, 2006.<sup>2</sup> AT&T Mobility was jointly owned and controlled by both AT&T and BellSouth prior to AT&T acquiring control of BellSouth. This FCN is substantially identical to that filed by the U.S. international carrier affiliates of AT&T Inc. on January 29, 2007.<sup>3</sup>

#### Answer to Question 10

AT&T Mobility recently discovered the affiliation detailed above that resulted from its relationship with BellSouth. Upon discovery, Applicants prepared the instant notification in an effort to comply with the requirements of Section 63.11 of the Commission's rules as expeditiously as possible.

#### Answer to Question 12

In response to Questions 12.b-c, Applicants certify in accordance with Section 63.18(k)(1) of the Commission's rules, 47 C.F.R. § 63.18(k)(1), that Canada is a WTO Member country.<sup>4</sup> As demonstrated below in response to Question 16, Applicants are entitled to retain non-dominant classification on this route pursuant to Section 63.10 of the Commission's rules, 47 C.F.R. § 63.10.

Pursuant to Section 63.10 of the Commission's rules, 47 C.F.R. § 63.10, Applicants qualify for continued non-dominant classification on the route between the U.S. and Canada because the foreign carrier affiliate, BSLD, has no market power on the foreign end of this route. BSLD's market share is under 50 percent in all relevant markets on the foreign end of the U.S.-Canada route, including the international transport and local access markets in Canada. Additionally, BSLD is not listed on the Commission's "List of Foreign Telecommunications Carriers that are Presumed to Possess Market Power in Foreign Telecommunications Markets."<sup>5</sup> Accordingly, Applicants are presumptively classified as non-dominant on this route.

**Answer to Question 17**

BSLD is authorized to provide telecommunications services to the public in Canada.

**Answer to Question 19**

Applicants do not provide services to Canada solely through the resale of international switched services of unaffiliated United States facilities-based carriers.

**Answer to Question 20**

AT&T Inc. ("AT&T"), through various wholly owned subsidiaries, indirectly holds 100% of AT&T Mobility's LLC Units. AT&T is a publicly traded holding company with no person or entity known to own 10% or more of the company's outstanding stock. The AT&T subsidiaries that directly hold the LLC Units in AT&T Mobility are SBC Long Distance, LLC ("SBC LD"); SBC Alloy Holdings, Inc. ("SBC Alloy"); AT&T Mobility Corporation ("AMC"); BLS Cingular Holdings, LLC ("BLS Cingular"); and BellSouth Mobile Data, Inc. ("BSMD") (*see* attached chart showing the interest held by each direct interest holder).

SBC LD's sole member is SBC Telecom, Inc., which is owned 100% by AT&T Teleholdings, Inc. ("ATI"). SBC Alloy is jointly owned by six (6) wholly owned, directly or indirectly held subsidiaries of AT&T: New Southwestern Bell Mobile Systems, Inc. ("New

SBMS;" 62.01%); ATI (20.08%); AWACS, Inc. (13.68%); New SBC Wireless, Inc. ("New SBCW;" 3.74%); AT&T Services, Inc. ("AT&T Services;" 0.47%); and AT&T Management Services, L.P. ("AT&T Management;" 0.03%). New SBMS has two owners: New SBCW (80%) and ATI (20%). AWACS, Inc. is directly owned by Delaware Valley Cellular Corporation, which is directly owned by New SBCW. AT&T Services is jointly owned by AT&T (83.07%); ATI (6.44%); and another indirect, wholly owned subsidiary of AT&T, Ameritech Services, Inc. (10.49%). AT&T Management Services Holdings, Inc. ("AT&T MSH") directly holds a 99% limited partnership interest in AT&T Management and holds 100% of AT&T-MSI, LLC, which directly holds a 1% general partnership interest in AT&T Management. AT&T directly owns ATI, New SBCW, and AT&T MSH.

AMC is a wholly owned subsidiary of AT&T, with 50% held directly by AT&T and 50% held indirectly through AT&T's 100% direct ownership of BellSouth Corporation ("BellSouth"). BLS Cingular has two members: AB Cellular Holding, LLC ("AB Cellular" - 97.60%) and Wireless Telecommunications Investment Company, LLC ("WTIC" - 2.40%). The members of AB Cellular are BSMD (97.70%) and RAM Broadcasting Corporation ("RAM;" 2.30%). In addition to being a member of BLS Cingular, BSMD directly owns RAM and is the sole member of WTIC. BSMD is directly owned by BellSouth Mobile Systems, Inc. ("BSMS"), which is directly owned by BellSouth Enterprises, Inc., which is owned 100% by BellSouth.

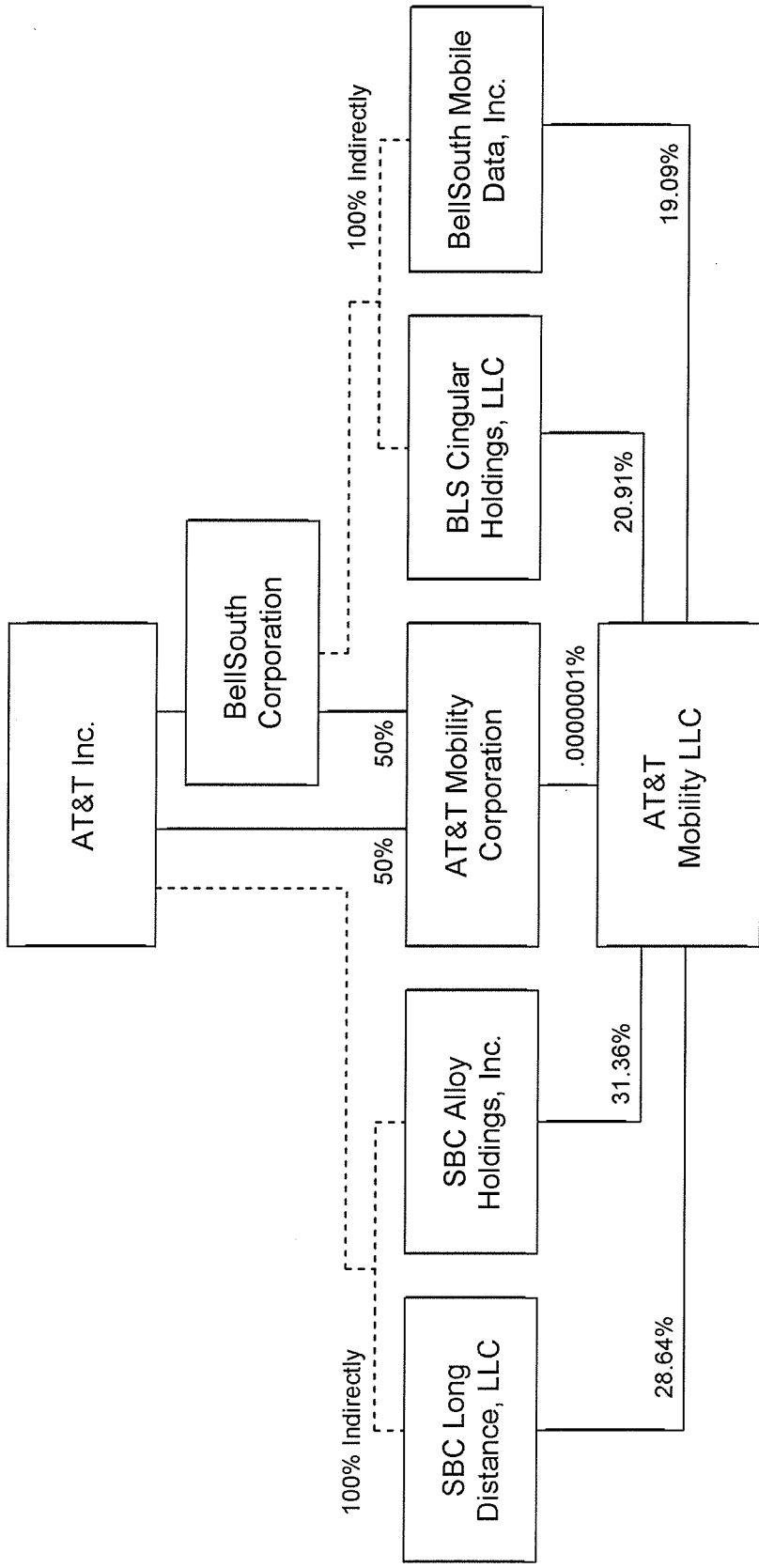
