Dear Ms. Dortch:

Pursuant to Section 63.11 of the Commission's Rules, 47 C.F.R. § 63.11, France Telecom Long Distance USA, LLC ("FTLD"), by its undersigned counsel, hereby files this foreign carrier post affiliation notification.¹

In accordance with Section 63.11(e) of the Commission's Rules, 47 C.F.R. § 63.11(e), FTLD provides the following information:

- (1) The names of the newly affiliated foreign carriers and the countries in which they are authorized to provide telecommunications services to the public are listed in Exhibit 1.
- (2) All countries listed in Exhibit 1 are WTO member countries.
- (3) FTLD is authorized to provide global facilities-based and resale services to all of the above listed countries pursuant to Section 214 authorizations granted by the Commission. See *In Re International Authorizations Granted, Public Notice*, DA 00-11, File Nos. ITC-214-19991215-00782, -00783, -00784 (Jan. 6, 2000).

¹ To the extent necessary, FTLD requests a waiver of the 30 days filing period contained in Section 63.11(c) of the Commission's Rules, 47 C.F.R. § 63.11(c).



(4) FTLD does not serve any of the countries listed in Exhibit 1 solely through the resale of the international switched services of unaffiliated U.S. facilities-based carriers.

(5) The ownership information required by Section 63.11(e)(5) of the Commission's Rules, 47 C.F.R. § 63.11(e)(5), is on file with the Commission in the above-referenced Section 214 authorizations.

(6) FTLD hereby certifies that it has not agreed to and will not in the future agree to accept special concessions directly or indirectly from any foreign carrier with respect to any U.S. international route where the foreign carrier possesses market power on the foreign end of the route.

(7) FTLD does not have any interlocking directorates, as defined in Section 63.09(g), 47 C.F.R. § 63.09(g), with any foreign carrier named in the notification.

(8) The present notification is subject to Section 63.11(c) of the Commission's Rules, 47 C.F.R. § 63.11(c). The actual dates of closing of the transactions are listed in Exhibit 1.

(9) FTLD hereby certifies that it satisfies the exceptions listed in Section 63.11(b)(1)-(2) of the Commission's Rules, 47 C.F.R. §§ 63.11(b)(1)-(2). FTLD hereby certifies that the countries listed in Exhibit 1 are WTO member countries. For those countries listed as "NO" in the Market Power column of Exhibit 1, FTLD certifies that those entities are providers of mobile services in each of the countries in which they operate. For those countries listed as "YES" in the Market Power column of Exhibit 1, FTLD hereby agrees to comply with the dominant carrier safeguards contained in Section 63.10 of the Commission's Rules, 47 C.F.R. § 63.10, effective upon the acquisition of the affiliation.
