Foreign Carrier Affiliation Notification**

Foreign Carrier Affiliation Notification

Pursuant to Section 63.11 of the Commission's rules, the below-listed Global Crossing carrier subsidiaries that hold international 214 authorizations (collectively, the "Global Crossing Carrier Subsidiaries") hereby submit this foreign carrier affiliation notification, relating to an affiliation with the following three foreign carriers: eircom Limited ("eircom") and Meteor Mobile Communications Ltd. ("Meteor") in Ireland, and eircom UK Limited ("eircom UK") in the United Kingdom. Specifically, this notification is being submitted by:

The Global Crossing Carrier Subsidiaries became affiliated with these foreign carriers as a result of a recent transaction by which their indirect parent, Singapore Technologies Telemedia Pte Ltd ("ST Telemedia"), acquired control of eircom, Meteor, and eircom UK.¹ That transaction was consummated on January 4, 2010.²

Answers to Questions 12 and 16

Ireland and the United Kingdom are World Trade Organization ("WTO") Member countries. eircom and Meteor own facilities in Ireland; eircom UK owns facilities in the United Kingdom.

With respect to the U.S.-United Kingdom route, the Global Crossing Carrier Subsidiaries presumptively qualify for non-dominant classification pursuant to Section 63.10(a)(3) of the Commission's rules. eircom UK lacks a 50 percent market share in the United Kingdom and is

not listed on the Commission's List of Foreign Telecommunications Carriers That Are Presumed to Possess Market Power in Foreign Telecommunications Markets.³

With respect to the U.S.-Ireland route, Meteor lacks a 50 percent market share in Ireland and is not listed on the Commission's List of Foreign Telecommunications Carriers That Are Presumed to Possess Market Power in Foreign Telecommunications Markets.⁴ However, the Commission presumes eircom to be dominant in Ireland.⁵ The Global Crossing Carrier Subsidiaries agree that, with respect to the U.S.-Ireland route, they will comply with the dominant carrier safeguards contained in Section 63.10 of the Commission's rules, subject to possible reclassification at a later date.⁶

Accordingly, the instant notification is eligible for the post-consummation notification procedures pursuant to Section 63.11(b) of the Commission's rules.

Answer to Question 17

eircom and Meteor are authorized to provide communications services in Ireland. eircom UK is authorized to provide communications services in the United Kingdom.
