ANSWER TO QUESTIONS 9 and 10

The foreign carrier affiliations identified in this notice resulted from transactions completed by Elantic Telecom, Inc., n/k/a Intellifiber Networks, Inc. (“Elantic”), Network Telephone Corporation’s (“NTC”) commonly-owned affiliate. NTC’s failure to notify the Commission of this new foreign carrier affiliate was an inadvertent oversight.

ANSWER TO QUESTIONS 12, 16 AND 17

NTC hereby provides notification of its affiliation with the following foreign carrier:

Canada WTO Member	Elantic Telecom, Inc., n/k/a Intellifiber Networks, Inc.	NTC and Elantic are each wholly-owned subsidiaries of Cavalier Telephone Corporation. (“Cavalier”) Elantic has a market share of less than 5% of the telecommunications market in Canada.

NTC requests continued classification as a nondominant carrier under Commission Rule §63.10¹ on all routes between the U.S. and Canada. NTC’s foreign carrier affiliate does not have market power on the foreign end of the route. Elantic lacks 50% market share in the international transport and local access market on the foreign end of the route. Accordingly, pursuant to Rule §63.10(a)(3), NTC is presumptively classified as non-dominant on these routes.
