Question 5 – Countries of affiliation

By this filing, Reach Ltd. ("REACH") notifies the FCC of affiliations with foreign carriers in the British Virgin Islands; Germany; Greece; Hong Kong; Japan; the Netherlands; Singapore; Thailand; and the United Kingdom.

Question 10 – Late notification

As appropriate, REACH requests a waiver of the requirement that carriers notify the FCC of foreign affiliations within 30 days after closing. REACH's failure to file within the specified timeframe was inadvertent in each instance. REACH notes that it clearly qualifies for continued nondominant treatment on all of the notified routes except Hong Kong, and that it is already subject to dominant carrier treatment on the Hong Kong route. REACH apologizes for any inconvenience resulting from its failure to file this notification in a timely manner.

Question 12.c.1 – Non-dominant carrier demonstration

REACH currently regulated as non-dominant on the British Virgin Islands, Germany, Greece, Japan, Netherlands, Singapore, Thailand, and United Kingdom routes. REACH asks that it continue to be regulated as a non-dominant carrier on these routes. Continued non-dominant treatment is appropriate on these routes because on each of these routes, REACH's foreign carrier affiliates lack 50 percent market share in the international transport and local access markets in their home countries. Currently, in their respective countries, each of these carriers either has not yet begun providing service or, if providing service: (1) controls less than 25 percent of the market; (2) competes against at least one other carrier that controls a majority of the international telecommunications market; and (3) lacks market power or facilities that would permit it to set market prices, control services or facilities, control market entry, or discriminate against unaffiliated U.S. carriers.

Question 12.c.2 – Agreement to dominant carrier treatment

REACH is currently subject to dominant carrier treatment on the U.S.-Hong Kong route, and accepts dominant carrier treatment with respect to the Hong Kong foreign carrier affiliation that is the subject of this Notification.

Ouestion 16 – Appropriateness of continued non-dominant treatment

Continued non-dominant treatment is appropriate for REACH on the British Virgin Islands, Germany, Greece, Japan, Netherlands, Singapore, Thailand, and United Kingdom routes since REACH's affiliates on these routes lack market power in the international transport and local access markets in their home countries, as demonstrated in the answer to Question 12.c.1 above.
