Foreign Carrier Affiliation Notification

Pursuant to Section 63.11 of the Commission's rules, AT&T Mobility LLC hereby submits on behalf of its subsidiaries and other affiliates that hold international Section 214 authorizations (collectively referred to as "AT&T Mobility" or "the Applicants")¹ this foreign carrier affiliation notification for an affiliation with a newly licensed carrier in Thailand, AT&T Worldwide Services (Thailand) Limited ("AT&T Thailand").

Answer to Question 10

This notification does not result from an acquisition. AT&T Thailand received a license to provide basic telecommunications services to the public effective on July 16, 2011, and expects to begin providing such services in the near future.

Answer to Questions 12 and 16

Applicants certify that Thailand is a WTO member country.² AT&T Thailand does not own facilities in Thailand.

Pursuant to Section 63.10 of the Commission's rules, 47 C.F.R. Sect. 63.10, Applicants qualify for continued non-dominant classification on the route between the U.S. and Thailand because AT&T Thailand LLC has no market power on the foreign end of this route. AT&T Thailand LLC has market shares under 50 percent in all relevant markets on the foreign end of the U.S.-Thailand route, including the international transport and local access markets in Thailand, and is not listed on the Commission's List of Foreign Telecommunications Carriers that are Presumed to Possess Market Power in Foreign Telecommunications Markets. *See* Public Notice, *The International Bureau Revises and Reissues the Commission's List of Foreign Telecommunications Carriers that are Presumed to Possess Market Sum Presumed to Possess Market Power in Foreign Telecommunications Carriers that are Presumed to Possess Markets, Jan. 26, 2007,*
