AMENDED ATTACHMENT TO FOREIGN CARRIER AFFILATION NOTIFICATION

Introduction

Windstream Corporation ("Windstream") files this amended attachment to File No. FCN-NEW-INTR2012-00009 to correct the list of subsidiaries included in the original attachment. Specifically, Windstream has no interest in or control of the following two entities, as Windstream previously divested its interest in those entities, with Commission approval.¹

Other than the elimination of these two entities from the list of subsidiaries included in the original attachment and the addition of this introduction, this attachment is identical to the attachment it replaces.

Background

On December 1, 2011, Windstream Corporation ("Windstream") and PAETEC Holding Corp. ("PAETEC") completed a transfer of control of PAETEC's subsidiaries from PAETEC to Windstream. The Commission approved the associated transfer of control of PAETEC's subsidiaries that hold International Section 214 authorizations in IB File Nos. ITC-T/C-20110819-00269, ITC-T/C-20110819-00270, ITC-T/C-20110819-00271, ITC-T/C-20110819-00275, ITC-T/C-20110819-00273, ITC-T/C-20110819-00274, ITC-T/C-20110819-00275, ITC-T/C-20110819-00276, ITC-T/C-20110819-00277 and ITC-T/C-20110819-00278 (the "International 214 Applications"). The International 214 Applications disclosed that one of PAETEC's subsidiaries, Intellifiber Networks, Inc. ("Intellifiber"), is a foreign carrier in Canada² and that as a result of the Transaction Windstream and Windstream's subsidiaries listed below that hold International Section 214 authorizations (the "Windstream Licensees") have become affiliated with a foreign carrier in Canada.³

The Windstream Licensees provide notification of their affiliation with the following foreign carrier:

		Intellifiber has a market share of less than 5% of the telecommunications market in Canada.

The Windstream Licensees request continued classification as nondominant carriers under Section 63.10 of the Commission's Rules on all routes between the United States and Canada. Intellifiber lacks 50 percent market share in the international transport and local access markets on the foreign end of the route and thus lacks sufficient market power on the foreign end to adversely affect competition in the U.S. market. Accordingly, pursuant to Section 63.10(a)(3), the Windstream Licensees are presumptively classified as non-dominant on these routes.

Response to Question 19

The Windstream Licensees provide service between the United States and Canada only through the resale of international switched services of unaffiliated U.S. facilities-based carriers.

Response to Question 20

Windstream and the Windstream Licensees acquired direct ownership of PAETEC and indirect ownership of Intellifiber. *See* IB File Nos. ITC-T/C-20110819-00269, ITC-T/C-20110819-00270, ITC-T/C-20110819-00271, ITC-T/C-20110819-00272, ITC-T/C-20110819-00273, ITC-T/C-20110819-00274, ITC-T/C-20110819-00275, ITC-T/C-20110819-00276, ITC-T/C-20110819-00277 and ITC-T/C-20110819-00278. The post-transaction ownership of the Windstream Licensees is provided in those applications and is incorporated by reference herein.

Windstream is a publicly held corporation. To Windstream's knowledge, no person or entity directly or indirectly owns or controls a ten percent (10%) or more interest in Windstream.

Response to Question 21:

Windstream, the Windstream Licensees and Intellifiber all have identical officers and directors and therefore have interlocking directorates with each other.
