#### **Response to Question 10**

The Verizon International Section 214 Licensees became affiliated with Verizon Bulgaria EOOD, Verizon Romania SRL, and Verizon Communications Slovakia s.r.o. more than thirty days prior to the filing of this foreign carrier affiliation notification, but the notification was not filed previously due to administrative oversight. The affiliates reported herein are all non-dominant and operate only as resale carriers. To the extent necessary, the

## **Response to Question 12**

The Verizon International Section 214 Licensees certify that their affiliates in Bulgaria, Romania, and Slovakia are all authorized to operate in WTO member countries. These affiliates lack market power in their respective destination markets and qualify for a presumption of non-dominance under Section 63.10(a)(3) of the Commission's rules, 47 C.F.R. § 63.10(a)(3). None of these foreign carriers is listed on the Commission's List of Foreign Telecommunications Carriers that Are Presumed to Possess Market Power in Foreign Telecommunications Markets. Information about each of these carriers is provided below:

- Verizon Bulgaria EOOD is authorized to provide fixed voice, data (PIP), Internet and VSAT services in Bulgaria. All public switched telephone network ("PSTN") services are offered on a resale basis. The company does not control bottleneck facilities and has market shares under 50 percent in all relevant markets on the foreign end of the U.S.–Bulgaria route, including the international transport and local access markets.
- Verizon Romania SRL resells fixed voice services in Romania. The company does not control bottleneck facilities and has market shares under 50 percent in all relevant markets on the foreign end of the U.S.–Romania route, including the international transport and local access markets.
- Verizon Communications Slovakia s.r.o. provides fixed voice, data (PIP) and Internet services in Slovakia. All PSTN services are offered on a resale basis. Verizon Communications Slovakia s.r.o. does not control bottleneck facilities or have a 50 percent or greater market share in the international transport and the local access markets in Slovakia.

### **Response to Question 16**

The Verizon International Section 214 Licensees request non-dominant treatment on the U.S.-Bulgaria, U.S.-Romania, and U.S.-Slovakia routes. See Response to Question 12 above.

### **Response to Question 17**

Verizon Bulgaria EOOD is authorized to provide telecommunications services to the public in Bulgaria. Verizon Romania SRL is authorized to provide telecommunications services to the public in Romania. Verizon Communications Slovakia s.r.o. is authorized to provide telecommunications services to the public in Slovakia.

### **Responses to Question 18**

The Verizon International Section 214 Licensees are authorized to provide facilitiesbased and resold international services on the U.S.-Bulgaria, U.S.-Romania, and U.S. Slovakia routes.

#### **Response to Question 19**

The Verizon International Section 214 Licensees do not serve Bulgaria, Romania, or Slovakia solely through the resale of international switched services of unaffiliated U.S. facilities-based carriers.

#### **Response to Question 20**

The Verizon International Section 214 Licensees are direct or indirect subsidiaries, or controlled partnerships, of Verizon. No person or entity has a ten percent or greater ownership interest in Verizon.
