Response to Question 10

Global Crossing Americas Solutions, Inc. (“GCAS”) makes this notification pursuant to 47 C.F.R. §§ 63.12(b)(1)(i), (b)(2)(i), and (b)(2)(ii). GCAS’s ultimate parent company, Level 3 Communications, Inc. (“Level 3 Parent”), has recently acquired a number of foreign affiliations as a consequence of open-market purchases of shares in Level 3 Parent by STT Crossing Ltd (“STT Crossing”), resulting in an aggregate interest in Level 3 of approximately 25.6 percent.¹ STT Crossing is indirectly owned and controlled by Temasek Holdings (Private) Limited (“Temasek”), which holds indirect, controlling interests in a number of foreign carriers.

Response to Question 12(b)

GCAS’s new foreign-carrier affiliates in Australia, Hong Kong, India, Indonesia, Japan, Korea, Malaysia, Philippines, Singapore, Sri Lanka, Taiwan, and the United Kingdom each own or lease facilities in their respective markets.²

Response to Question 12(c)(1)

GCAS is eligible for post-consummation notification of foreign affiliations pursuant to 47 C.F.R. §§ 63.11(b)(1)(i), (b)(2)(i), and (b)(2)(ii).

With respect to the carriers identified by an asterisk (*) in Table 1 below, GCAS is entitled to retain non-dominant status on the associated international routes pursuant to 47 C.F.R. §§ 63.10(a)(3) and 63.11(b)(1)(i). The Commission has previously acknowledged that these carriers lack market power in their respective geographic markets.³ Each of these foreign carriers has less than 50-percent market share in either the international transport market or local access market of its respective geographic market. None of these newly-affiliated foreign carriers has since appeared on the Commission's list of foreign telecommunications carriers presumed to possess market power in foreign telecommunications markets.⁴

With respect to the other foreign carriers (other than SingTel) listed in Table 1 below, GCAS is entitled to retain non-dominant status on the associated international routes pursuant to 47 C.F.R. §§ 63.10(a)(3) and 63.11(b)(2)(ii). Each of these foreign carriers (other than SingTel) lacks market power in its respective geographic market. Each (except for SingTel) has less than

50-percent market share in either the international transport market or local access market of its respective geographic market. Except for SingTel, none of these foreign carriers appears on the Commission's list of foreign telecommunications carriers presumed to possess market power in foreign telecommunications markets.⁵ Except for SingTel, these foreign carriers therefore qualify for presumptions of non-dominance pursuant to 47 C.F.R. § 63.10(a)(3) and exemptions from the dominant carrier safeguards in 47 C.F.R. §§ 63.10(c) through (e).

Pursuant to 47 C.F.R. § 63.11(b)(2)(ii), GCAS agrees to be regulated as dominant on the U.S.-Singapore route as a consequence of its affiliation with SingTel. GCAS certifies that SingTel is authorized to operate in Singapore, a member of the World Trade Organization (“WTO”).⁶

Response to Question 16

For the reasons set forth in response to Question 12(c)(1) above, GCAS requests continued regulation as a non-dominant international carrier on all routes, except for the U.S.-Singapore route. Except for SingTel, all of the foreign carriers listed in Table 1 below are entitled to be classified presumptively as non-dominant.

Response to Question 17:

As required by 47 C.F.R. §§ 63.11(e)(1) and (2), GCAS certifies that it is affiliated with the carriers listed in Table 1 below as of May 16, 2012.

Australia, Hong Kong, India, Indonesia, Japan, Korea, Malaysia, Philippines, Singapore, Sri Lanka, Taiwan, and the United Kingdom are all WTO members.⁷
