### Question 5 – Countries of affiliation

By this filing, Singapore Telecom USA, Inc. ("SingTel USA") notifies the FCC of an affiliation with one or more foreign carriers in Australia, China, India, Indonesia, Hong Kong, Malaysia, Taiwan, Thailand, and the United Kingdom (the "Notified Routes").

### Question 10 – Late notification

As appropriate, SingTel USA requests a waiver of the requirement that carriers notify the FCC of foreign affiliations within 30 days after closing. SingTel USA's failure to file within the specified timeframe was inadvertent. Also, it is possible that some of the foreign carriers on the list do not precisely qualify as foreign carriers under the FCC's rules; regardless, SingTel USA has elected to notify the Commission of these affiliations out of an abundance of caution. SingTel USA notes that it clearly qualifies for continued nondominant treatment on each of the Notified Routes. SingTel USA apologizes for any inconvenience resulting from its failure to file this notification in a timely manner.

### Question 12.c.1 – Non-dominant carrier demonstration

SingTel USA is currently regulated as non-dominant in its provision of service between the U.S. and each of the Notified Routes. SingTel USA asks that it continue to be regulated as a non-dominant carrier on each of these routes. Continued non-dominant treatment is appropriate in each case because on each of the Notified Routes, SingTel USA's affiliate lacks a 50 percent market share in the international transport and local access markets in the foreign country in which it operates. Currently, the new foreign carrier affiliate on each Notified Route (1) controls less than 25 percent of the market; (2) competes against at least one other carrier that controls a majority of the international telecommunications market; and (3) lacks market power or facilities that would permit it to set market prices, control services or facilities, control market entry, or discriminate against unaffiliated U.S. carriers.

### Question 16 – Appropriateness of continued non-dominant treatment

Continued non-dominant treatment is appropriate for SingTel USA in its provision of service between the U.S. and the Notified Routes since SingTel USA's affiliate on each of these routes lacks market power in the international transport and local access markets in the foreign country in which it operates, as demonstrated in the answer to Question 12.c.1 above.

# Question 18 - FCC authorizations and services authorized

SingTel USA was authorized to provide switched and private-line international services on a facilities-based and resale basis to the countries listed in response to Question 17 in FCC File No. ITC-214-19981005-00681, DA 98-2396, rel. Nov. 24, 1998 (Australia, Thailand, Hong Kong, the U.K.) and FCC File No. ITC-214-19981005-00680, DA 98-2396, rel. Nov. 24, 1998 (China, India, Indonesia, Malaysia, Taiwan).

### Question 19 - Countries served solely through resale of unaffiliated carriers

SingTel USA serves none of the Notified Routes solely through the resale of the international switched services of unaffiliated U.S. facilities-based carriers.

### Question 20 – Ownership information

SingTel USA is a wholly-owned direct subsidiary of Singapore Telecommunications Limited ("SingTel"), a corporation organized under the laws of Singapore. The address of SingTel is 31 Exeter Road, Comcentre, Singapore 239732. The principal business of SingTel is the provision of local intercity, and international communications services in Singapore.

Temasek Holdings (Private) Limited ("Temasek") holds an approximately 54.45 percent ownership interest in SingTel (as of July 12, 2012). Temasek is wholly-owned by the Singapore Minister for Finance; it is an investment holding company with diverse interests in a wide spectrum of industries including media, financial services, transportation, ship repair and engineering, properties, hotels, property management and consultancy, construction, leisure and recreation. The address of Temasek is 60B Orchard Road, #06-18 Tower 2, The Atrium@Orchard, Singapore 238891. To the best of SingTel USA's knowledge and belief, Temasek holds ownership interests in other telecommunications companies in Singapore which are competitors of SingTel and which hold certain licenses to provide mobile cellular telephone and radio paging services in Singapore. However, SingTel USA is uncertain as to whether Temasek holds ownership interests in telecommunications companies in other countries.

No other stockholder holds 10 percent or more of the stock in SingTel USA through SingTel.
