Response to Question 9:

Global Crossing North America, Inc. (“GCNA”), makes this notification pursuant to 47 C.F.R. § 63.11(c). GCNA’s indirect parent company, Level 3 Communications, Inc., has established a new subsidiary, Level 3 Communications RS d.o.o. (“Level 3 Serbia”), to operate as a competitive carrier in Serbia. Level 3 Serbia will own or lease facilities in Serbia.

Response to Question 13:

Level 3 Serbia was licensed on October 28, 2013, to provide Internet protocol, data transport, and related services in Serbia but has not yet commenced service. Serbia has nearly concluded its WTO accession negotiations but is not yet a WTO member.¹

Response to Question 14:

Level 3 Serbia lacks market power in Serbia. As a prospective entrant that has not yet commenced service, Level 3 Serbia currently has no customers and therefore lacks 50-percent market share in either the Serbian international transport market or the Serbian local access market. Level 3 Serbia does not appear on the Commission’s list of foreign telecommunications carriers presumed to possess market power in foreign telecommunications markets.² Level 3

Serbia therefore qualifies for presumptions of non-dominance pursuant to 47 C.F.R.

§ 63.10(a)(3) and exemptions from the dominant carrier safeguards in 47 C.F.R. § 63.10(c)-(e).

Response to Question 16:

For the reasons stated in response to Question 14 above, GCNA is entitled to retain non-dominant status on its newly affiliated route pursuant to 47 C.F.R. §§ 63.10(a)(3) and 63.11(f).

As required by 47 C.F.R. § 63.11(e)(3), GCNA certifies that it is authorized to serve Serbia pursuant to its sole international Section 214 authorization for global facilities-based and global resale services pursuant to 47 C.F.R. §§ 63.18(e)(1) and (2), FCC File No. ITC-214-19980520-00334.

Response to Question 19:

As required by 47 C.F.R. § 63.11(e)(4), GCNA certifies that it does not serve Serbia solely through the resale of international switched services of unaffiliated U.S. facilities-based carriers.
