Response to Question 10:

Global Crossing North America, Inc. ("GCNA"), makes this notification pursuant to 47 C.F.R. § 63.11(b)(2)(i). GCNA's indirect parent company, Level 3 Communications, Inc., has established new subsidiaries to operate as competitive carriers in Estonia, Russia, and South Africa.

Response to Question 12(b):

GCNA's new foreign-carrier affiliates all own or lease facilities in their respective markets.

Response to Question 12(c)(1):

GCNA is entitled to retain non-dominant status on its newly affiliated routes pursuant to 47 C.F.R. §§ 63.10(a)(3) and 63.11(f). GCNA's new foreign-carrier affiliates lack market power in their respective markets. As new entrants in the their respective market, GCNA's newly-affiliated foreign carriers have negligible market share, and lack 50-percent market share in either the international transport market or local access market of their respective geographic markets. These newly-affiliated foreign carriers do not appear on the Commission's list of foreign telecommunications carriers presumed to possess market power in foreign telecommunications markets. These foreign carriers therefore qualify for presumptions of non-
