Pursuant to Sections 1.768 of the FCC's rules, Antilles Crossing-St. Croix, Inc. ("ACSC") (FRN 0013963624), the holder of a submarine cable landing license to operate the Antilles Crossing private fiber-optic cable system (File No. SCL-LIC-20031125-00032) hereby notifies the Commission of a new foreign carrier affiliation to be effected through the acquisition by Digicel Curacao Holdings BV (d/b/a "Digicel Curacao"), an affiliate of ACSC, of Santa Barbara Utilities N.V. (d/b/a "Tres Networks"), a provider of fixed and international long distance telecommunications services and internet access service in Curacao. Simultaneously with this submission, Digicel USA, Inc., another affiliate of Digicel Curacao, is filing a new foreign carrier affiliation relating to the same transaction, pursuant to Section 63.11 of the Commission's rules.
