### Question 5 – Countries of affiliation

By this filing, Singapore Telecom USA, Inc. ("Singtel USA") notifies the Commission of its affiliation with foreign carriers in Bangladesh, India, and Indonesia (the "Notified Routes").

#### Question 10 – Late notification

This notification is being filed more than 30 days after consummation of the transactions resulting in affiliations with the foreign carriers. Singtel USA's failure to file within the specified timeframe was inadvertent, and Singtel USA apologizes for any inconvenience caused by its failure to file this notification in a timely manner. Singtel USA notes that the affiliations reported herein are not affiliations required to be reported prior to consummation under 47 C.F.R. § 63.11(a). Furthermore, because Singtel USA qualifies for continued non-dominant treatment on the Notified Routes, this notification should not change the Commission's regulatory treatment of Singtel USA.

#### Question 16 – Continued qualification for non-dominant status

Singtel USA should continue to be regulated as a non-dominant carrier, both on the Notified Routes and on all routes where it is currently so regulated. The foreign carrier affiliates listed in the response to Question 17, below, are not monopoly providers of communications services in their respective countries. See 47 C.F.R. § 63.10(a)(3). As required by the Commission's rules regarding classification of U.S.-international carriers, 47 C.F.R. § 63.10, Singtel USA can demonstrate that the foreign carrier affiliates lack sufficient market power in their respective countries to affect competition adversely in the U.S. market. Pacific Bangladesh Telecom Limited, Bharti Airtel Limited, and PT Telekomunikasi Selular are not listed on the Commission's List of Foreign Telecommunications Carriers that are Presumed to Possess Market Power in Foreign Telecommunications Markets. In addition, all three companies are primarily engaged in the provision of wireless phone and data services. As mobile wireless service providers, they lack sufficient market power to affect competition adversely in the U.S.<sup>2</sup> and do not control bottleneck facilities in their respective markets.<sup>3</sup> Based on publicly available information, each carrier listed in the response to Question 17, below, holds less than 50 percent market share in facilities that are necessary for the provision of international services by U.S. telecommunications companies, including international transport and local access facilities in its respective market.

### Question 19 – Countries served solely through resale of services

Singtel USA serves none of the Notified Routes solely through the resale of international switched services of unaffiliated U.S. facilities-based carriers.

#### Question 20 – Ownership information

Singtel USA is a wholly-owned direct subsidiary of Singapore Telecommunications Limited ("Singtel"), a corporation organized under the laws of Singapore. Singtel's registered office is at 31 Exeter Road, Comcentre, Singapore 239732. Singtel is principally engaged in the provision of local and international telecommunications services.

Temasek Holdings (Private) Limited ("Temasek") is Singtel's largest shareholder, holding 51% of issued shares as of March 31, 2015. Temasek is a state-owned investment holding company with interests in telecommunications, financial services, transportation, real estate and other industries. To the best of Singtel USA's knowledge and belief, Temasek holds ownership interests in other telecommunications and media companies in Singapore, including Singtel competitors. Temasek's address is 60B Orchard Road, #06-18 Tower 2, The Atrium @ Orchard, Singapore 238891.
