#### ATTACHMENT TO FOREIGN CARRIER AFFILIATION NOTIFICATION

### **Background**

On January 19, 2018, Zayo Group, LLC ("Zayo") completed the acquisition of Optic Zoo Networks Ltd. ("Optic Zoo"), a Vancouver-based dark fiber network provider that is a foreign carrier in Canada pursuant to its registration as a non-dominant carrier and Basic International Telecommunication Services ("BITS") license issued by the Canadian Radio-Television & Telecommunications Commission ("CRTC"). Also on January 19, 2018, Zayo completed the acquisition of Garth Telecom Services Inc. ("Garth Telecom"), a Vancouver-based fiber network provider that is a foreign carrier in Canada pursuant to its registration as a non-dominant carrier issued by the CRTC. On January 29, 2018, Zayo Infrastructure Spain, S.L. ("ZI-Spain") was granted a registration as an Electronic Communications Network Provider and Electronic Communications Service Provider by the Spanish National Commission on Markets and Competition ("CNMC") and is therefore a foreign carrier in Spain. Further, Zayo Italy S.r.l. ("Zayo-Italy") has applied for a registration as an Electronic Communications Network Provider and Electronic Communications Service Provider with the Italian Ministry of Economic Development ("Ministry") and expects issuance of the registration by March 31, 2018. As a result, Zayo and its current (and future) subsidiaries listed in Response to Question 18 (collectively, the "Company") (a) are affiliated with Optic Zoo and Garth Telecom, foreign carriers in Canada, and ZI-Spain, a foreign carrier in Spain, and (b) will become affiliated with a foreign carrier in Italy, Zayo-Italy, upon issuance of its registration.

#### **Response to Question 10 - Post Notification**

The new foreign carrier affiliations with Optic Zoo and Garth Telecom resulted from the transactions described above. The new foreign carrier affiliation with ZI-Spain resulted from the grant of a registration to ZI-Spain by the CNMC. The new foreign carrier affiliated with Zayo-Italy will result from the expected grant of a registration to Zayo-Italy by the Ministry.

In addition, the Company has other pre-existing foreign carrier affiliations, which have been identified in various applications to acquire control of various entities that hold international Section 214 authorizations, including most recently in applications for the proposed acquisition of Spread Telecommunications, LLC by Zayo.<sup>1</sup> However, a separate foreign carrier affiliation notification ("FCAN") was filed only for some of the affiliations.<sup>2</sup> To the extent necessary, the Company requests waiver from the requirement to file this Notification within thirty days of each foreign carrier affiliation of the Company for which a separate FCAN has not been filed.

The Company requests continued classification as a nondominant carrier under Section 63.10 of the Commission's Rules on all routes between the United States and Canada. Optic Zoo and ZI-Spain lack, and Zayo-Italy will lack, 50 percent market share in the international transport and local access markets on the foreign end of the routes and thus lack sufficient market power on the foreign end to adversely affect competition in the U.S. market. Accordingly, pursuant to Section 63.10(a)(3), the Company is presumptively classified as non-dominant on these routes.

Zayo holds a Reseller Registration and BITS License in Canada and thus is itself a nondominant foreign carrier in Canada. As disclosed in prior filings with the Commission by the Company,<sup>3</sup> the Company is also affiliated with the following foreign carriers:



# Corporate Ownership Structure of Zayo\* (U.S. International Carrier Subsidiaries)


