Notification of Foreign Carrier Affiliates

Sprint Communications Company L.P., as well as Sprint Communications, Inc.; Sprint Spectrum L.P.; SprintCom, Inc.; US Telecom, Inc.; and Virgin Mobile USA, L.P. (together “Sprint” or “Sprint International Licensees”) hereby submit this foreign carrier affiliation notification (“FCN”) pursuant to Sections 63.11 and 1.768 of the Federal Communications Commission’s (“FCC’s” or “Commission’s”) rules, 47 C.F.R. §§ 63.11. and 1.768.

Sprint makes this notification for the purpose of providing a comprehensive current list of its foreign carrier affiliates. Among other measures, this notification serves to update information for all FCN filings it has made previously. It is Sprint’s intention that this comprehensive notification will supplant its prior FCN filings. This filing also provides notice of certain foreign carriers affiliated with Sprint through SoftBank Group Corp. that were inadvertently omitted from prior FCN filings. Should the Commission deem it necessary, Sprint respectfully requests a waiver of 47 C.F.R. §§ 1.768(c) and 63.11(c) in order to provide formal notification of these foreign carrier affiliations and submits that there is ample good cause for any such waiver.¹

Response to Question 5

Annex A provides the names of the foreign carrier affiliates and the countries in which they are authorized to provide telecommunications services to the public or where they own or control a cable landing station.

The Sprint-SoftBank transaction was highly publicized and the proposed foreign carrier affiliations are well known to the Commission. Response to Question 16

Sprint certifies as follows:

All of the countries listed in Annex A are WTO Member countries.²

The following foreign carrier affiliates own “facilities” pursuant to Sections 63.11 (b)(1)(ii), 47 C.F.R. § 63.1(b)(1)(ii), and 1.768(b)(1)(ii), 47 C.F.R. § 1.768(b)(1)(ii), in their respective countries: Sprint International Argentina SRL (Argentina), Sprint International Australia Pty Ltd (Australia), Sprint International Austria GmbH (Austria), Sprint International Communications Canada ULC (Canada), Sprint International Colombia Ltda. (Colombia), Sprint Hong Kong Limited (Hong Kong), SprintLink Germany GmbH (Germany), Sprint International Japan Corporation (Japan), SprintLink International Malaysia SDN. BHD. (Malaysia), SIHI Mexico S. de R.L. de C.V (Mexico), Sprint International Communications Singapore Pte. Ltd (Singapore), Sprint (Thailand) Limited (Thailand), and Sprintlink UK Limited (United Kingdom). In addition, Softbank Corp. holds ownership in three submarine cable landing stations in Japan.

Pursuant to Section 63.10(a)(3) of the Commission’s rules, 47 C.F.R. § 63.10(a)(3), Sprint continues to qualify for non-dominant classification on the routes between the United States and the countries listed herein because none of the affiliates listed hold market power on the foreign end of these routes, respectively. Additionally, none of the affiliates listed hold market power in the destination market for any of the applicable submarine cable landing licenses as described in 47 C.F.R. § 1.768(b)(2).

None of the affiliates listed own or control any bottleneck facilities or have a fifty percent or greater market share in the international transport and local access markets in their respective countries. Moreover, none of the affiliates listed above are on the Commission’s List of Foreign Telecommunications Carriers that are Presumed to Possess Market Power in Foreign Telecommunications Markets. *See Public Notice, The International Bureau Revises and Reissues the Commission’s List of Foreign Telecommunications Carriers that are Presumed to Possess Market Power in Foreign Telecommunications Markets*, Jan. 26, 2007, available at https://apps.fcc.gov/edocs_public/attachmatch/DA-07-233A1.pdf. Accordingly, pursuant to Section 63.10(a)(3), 47 C.F.R. § 63.10(a)(3), Sprint continues to qualify for non-dominant classification on the routes between the United States and the countries listed herein.
