

Foreign Carrier Notification of Jive Communications, INC.

Question 5 – Countries of affiliation

By this filing, Jive Communications, INC. (“Jive”) notifies the Commission of its affiliation with foreign carriers in Brazil, Canada, and Mexico (the “Notified Routes”).

Question 10 – Late notification

This notification is being filed more than 30 days after consummation of the steps resulting in affiliations with the foreign carriers. Jive’s failure to file within the specified timeframe was inadvertent, and Jive apologizes for any inconvenience caused by its failure to file this notification in a timely manner. The affiliations reported herein are not affiliations required to be reported prior to consummation under 47 C.F.R. § 63.11(a). Furthermore, because Jive qualifies for continued non-dominant treatment on the Notified Routes, this notification should not change the Commission’s regulatory treatment of Jive.

Question 11 – Qualification for post notification

These transactions qualify for post notification under both Section 63.11(b)(1)(ii) and (b)(2)(i) for each foreign carrier listed in this notification.

These transactions qualify for post notification under Section 63.11(b)(1)(ii) because the foreign carriers provide only resale service. The carriers and their markets are listed in response to Question 17.

These transaction also qualify for post notification under Section 63.11(b)(2)(i) because each of the foreign carriers operates in a WTO member nation and Jive is entitled to retain its non-dominant classification on each route pursuant to the requirements of Section 63.10. Specifically, Jive can demonstrate that the foreign carrier affiliates lack sufficient market power in their respective countries to affect competition adversely in the U.S. market. Jive Telecomunicações do Brasil Ltda., Jive Communications Technology Canada, Ltd., and Jive Communications Mexico S.a. de R. L. de C.V. are not listed on the Commission’s List of Foreign Telecommunications Carriers that are Presumed to Possess Market Power in Foreign Telecommunications Markets.¹ In addition, all three companies are resellers of telecommunications services, and as resellers, they lack sufficient market power to affect competition adversely in the U.S. and do not control bottleneck facilities in their respective

markets.² Finally, each carrier listed in the response to Question 17, below, holds less than 50 percent market share (in fact, holds no market share) in facilities that are necessary for the provision of international services by U.S. telecommunications companies, including international transport and local access facilities in its respective market.

Question 16 – Continued qualification for non-dominant status

Jive should continue to be regulated as a non-dominant carrier, both on the Notified Routes and on all of the other routes where it is authorized to provide service. The foreign carrier affiliates listed in the response to Question 17 are not monopoly providers of communications services in their respective countries. *See* 47 C.F.R. § 63.10(a)(3). As required by the Commission’s rules regarding classification of U.S.-international carriers, 47 C.F.R. § 63.10, Jive can demonstrate that the foreign carrier affiliates lack sufficient market power in their respective countries to affect competition adversely in the U.S. market. As described in response to Question 11, Jive Telecomunicações do Brasil Ltda., Jive Communications Technology Canada, Ltd., and Jive Communications Mexico S.a. de R. L. de C.V. (a) are not listed on the Commission’s List of Foreign Telecommunications Carriers that are Presumed to Possess Market Power in Foreign Telecommunications Markets; (b) all are resellers of telecommunications services, and as resellers, lack sufficient market power to affect competition adversely in the U.S. and not control bottleneck facilities in their respective markets; and (c) all hold less than 50 percent market share in facilities that are necessary for the provision of international services by U.S. telecommunications companies, including international transport and local access facilities in their respective markets.
