#### LogMeIn Audio LLC – Foreign Carrier Affiliation Notification

# **ATTACHMENT 1**

#### Question 12(c)

By this filing, LogMeIn Audio LLC ("LMI Audio") notifies the Commission of its affiliations with the following foreign carriers: (i) Jive Telecomunicações do Brasil Ltda. ("Jive Brazil"), a reseller of telecommunications in Brazil; (ii) Jive Communications Technology Canada, Ltd. ("Jive Canada"), a reseller of telecommunications in Canada, and (iii) Jive Communications Mexico S.a. de R.L. de C.V. ("Jive Mexico," together with Jive Brazil and Jive Canada, the "Foreign Carriers"), a reseller of telecommunications in Mexico.

These affiliations qualify for post notification because each of the Foreign Carriers is nondominant on the routes between the U.S. and each of the respective destination markets. Each of the Foreign Carriers provides only resale service in their respective markets. In addition, Brazil, Canada and Mexico are each WTO member nations, and LMI Audio is entitled to retain its nondominant classification on each route pursuant to the requirements of Section 63.10(a)(3) of the Commission's rules. None of the Foreign Carriers is included in the Commission's list of foreign carriers that are presumed to possess "market power" in its markets, and thus, each is entitled to the presumption of non-dominance.<sup>1</sup> Moreover, the Foreign Carriers hold significantly less than a 50 percent market share in the international transport and local access markets on the foreign end of the relevant routes.

# **Question 16**

LMI Audio requests continued regulation as a non-dominant international carrier pursuant to Section 63.10 of the Commission's rules. In response to Question 12(c) above, the Foreign Carriers do not possess market power in their respective markets. In addition, the Foreign Carriers are resellers of telecommunications services and lack sufficient market power to affect competition adversely in the U.S. and do not control bottleneck facilities in their respective markets.<sup>2</sup> Therefore, LMI Audio is entitled to non-dominant classification on the affiliated routes.

#### **Question 17**

On April 3, 2018, LogMeIn, Inc., the ultimate parent company of LMI Audio, acquired Jive Communications, Inc., which wholly owns each of the Foreign Carriers. Therefore, as of that date, LMI Audio became affiliated with the following foreign carriers: (i) Jive Telecomunicações do Brasil Ltda., a reseller of telecommunications in Brazil; (ii) Jive

Communications Technology Canada, Ltd. a reseller of telecommunications in Canada, and (iii) Jive Communications Mexico S.a. de R.L. de C.V., a reseller of telecommunications in Mexico.

#### Question 18

LMI Audio holds international Section 214 authority granted in File No. ITC-214-20090113-00015 to provide resale service in accordance with Section 63.18(e)(2) of the Commission's rules.

## **Question 19**

To the extent LMI Audio serves the U.S. routes to Brazil, Canada or Mexico, such service is solely through the resale of international switched services of unaffiliated U.S. facilities-based carriers.
