Dear Ms. Dortch:

Sprint Corporation (“Sprint”) wholly owns, directly or indirectly, its subsidiaries Sprint Communications Company L.P.; Sprint Communications, Inc.; Sprint Spectrum L.P.; SprintCom, Inc.; US Telecom, Inc.; and Virgin Mobile USA, L.P., the filers of the above-referenced foreign carrier notifications (“FCNs”).

Please be advised that Sprint recently acquired a majority interest in PRWireless PR, LLC, which holds an international section 214 authorization. By this letter, Sprint supplements its responses to Questions 4 and 18 of the above-referenced FCNs¹ to add PRWireless PR, LLC, to the list of Sprint companies holding an international 214 authorization:

4. The jurisdiction of formation for PRWireless PR, LLC, is Delaware.

18. PRWireless PR, LLC holds authority to operate as a facilities-based carrier in accordance with the provisions of 47 C.F.R. §§ 63.18(e)(1) & (2), pursuant to ITC-214-19990615-00426.

Additionally, Sprint supplements its responses to Question 20 of the above-referenced FCNs to provide the following ownership information for PRWireless PR, LLC.

Please note that this filing also supplements FCN-NEW-20180216-00005 in particular to update the ownership information for Sprint Corporation following a *pro forma* internal restructuring effected on April 26, 2018.² Specifically, as indicated below, SoftBank Group International GK was replaced by SoftBank Group Capital Limited as an intermediate holding company positioned between SoftBank Group Corp. and Sprint Corporation.
