

**ATTACHMENT 1 TO FCC ELECTRONIC FORM  
Foreign Carrier Affiliation Notification**

Deutsche Telekom North America, Inc. (“DTNA”) hereby submits this Foreign Carrier Affiliation Notification (“FCAN”) pursuant to Section 63.11 of the Federal Communications Commission’s (“FCC”) Rules, 47 C.F.R. § 63.11. On July 1, 2020 Deutsche Telekom AG (“DT”), DTNA’s ultimate parent company, reorganized its operations. This internal reorganization resulted in the creation of several new foreign carrier affiliates. DT also changed the names of certain existing affiliates. In addition, several prior foreign carrier affiliates were eliminated. As a result, DTNA is taking this opportunity to provide an updated list of all of its current foreign carrier affiliations (see Attachment 2). None of the foreign carrier affiliates identified in Attachment 2 are subsidiaries of DTNA. Rather, all carriers listed are direct or indirect subsidiaries of its ultimate parent company, DT.

**Answer to Questions 12 and 16:**

The new foreign carrier affiliates are all enterprise customer service providers which may own Internet or related equipment to provide enterprise services. None of the new foreign carrier affiliates listed in Attachment 2 is a monopoly provider of communications services in the market in which it operates, nor do any of these new affiliates have a fifty percent or greater market share in the international transport and local access markets in the listed country.

DTNA is authorized to provide global or limited global facilities-based and resale services. *See* Authorization Granted, Public Notice, File No. ITC-214-20020927-00514 granted November 27, 2002.<sup>1</sup>

DTNA does not serve any of the countries listed in Attachment 2 solely through the resale of international switched services of unaffiliated U.S. facilities-based carriers.

approximately 80 percent of the ownership interests in KfW which, as described above, holds approximately 17 percent of the ownership interests in DT. Thus, FRG is deemed to hold approximately 32 percent of DT.

**Answer to Question 21:**

DTNA has one interlocking directorate with one foreign carrier listed in Attachment 2. Kevin Mulholland, Chief Executive Officer of DTNA, is a member of the Board of Directors for both DTNA and Deutsche Telekom Global Business Solutions Canada Inc.
