Foreign Carrier Affiliation Notification

Pursuant to Section 63.11 of the Commission's rules, AT&T Corp. and the U.S. international carrier affiliates of AT&T Inc. Answer to Question 10

These foreign carrier affiliation notifications do not result from an acquisition. AT&T Malaysia received a license to provide basic telecommunications services to the public effective on March 8, 2010, and expects to begin providing such services in the near future.

Answer to Questions 12 and 16

The above-listed U.S. international carrier affiliates of AT&T certify that Malaysia is a WTO member country.¹ AT&T Malaysia does not presently own facilities in Malaysia but may acquire such facilities in the future.

Pursuant to Section 63.10 of the Commission's rules, 47 C.F.R. Sect. 63.10, the above-listed U.S. international carrier affiliates of AT&T qualify for continued non-dominant classification on the route between the U.S. and Malaysia because their new

affiliate in Malaysia, AT&T Malaysia, has no market power on the foreign end of this route. AT&T Malaysia has market shares under 50 percent in all relevant markets on the foreign end of the U.S.-Malaysia route, including the international transport and local access markets in Malaysia. Additionally, AT&T Malaysia is not listed on the Commission's List of Foreign Telecommunications Carriers that are Presumed to Possess Market Power in Foreign Telecommunications Markets. *See* Public Notice, *The International Bureau Revises and Reissues the Commission's List of Foreign Telecommunications Carriers that are Presumed to Possess Market Power in Foreign Telecommunications Markets*, Jan. 26, 2007, http://hraunfoss.fcc.gov/edocs_public/attachmatch/DA-07-233A1.pdf. Accordingly, pursuant to Section 63.10(a)(3), the above-listed U.S. international carrier affiliates of AT&T are presumptively classified as non-dominant on this route.

AT&T Worldwide Network Services (Malaysia) Sdn. Bhd. ("AT&T Malaysia") is authorized to provide telecommunications services to the public in Malaysia.²
