### Foreign Carrier Affiliation Notification

Pursuant to Section 63.11 of the Commission's rules, AT&T Mobility LLC hereby submits on behalf of its subsidiaries and other affiliates that hold international Section 214 authorizations (collectively referred to as "AT&T Mobility" or "the Applicants")<sup>1</sup> this foreign carrier affiliation notification for an affiliation with a newly licensed carrier in Malaysia, AT&T Worldwide Network Services (Malaysia) Sdn. Bhd. ("AT&T Malaysia").

#### **Answer to Question 10**

This foreign carrier affiliation does not result from an acquisition. AT&T Malaysia received a license to provide basic telecommunications services to the public effective on March 8, 2010, and expects to begin providing such services in the near future.

#### **Answer to Questions 12 and 16**

Applicants certify that Malaysia is a WTO member country.<sup>2</sup> AT&T Malaysia does not presently own facilities in Malaysia but may acquire such facilities in the future.

Pursuant to Section 63.10 of the Commission's rules, 47 C.F.R. Sect. 63.10, Applicants qualify for continued non-dominant classification on the route between the U.S. and Malaysia because their new affiliate in Malaysia, AT&T Malaysia, has no market power on the foreign end of this route. AT&T Malaysia has market shares under 50 percent in all relevant markets on the foreign end of the U.S.-Malaysia route, including the international transport and local access markets in Malaysia. Additionally, AT&T Malaysia is not listed on the Commission's List of Foreign Telecommunications Carriers that are Presumed to Possess Market Power in Foreign Telecommunications Markets. *See Public Notice, The International Bureau Revises and Reissues the Commission's List of Foreign Telecommunications Carriers that are Presumed to Possess Market Power in Foreign Telecommunications Markets*, Jan. 26, 2007, [http://hraunfoss.fcc.gov/edocs\\_public/attachmatch/DA-07-233A1.pdf](http://hraunfoss.fcc.gov/edocs_public/attachmatch/DA-07-233A1.pdf). Accordingly, pursuant to Section 63.10(a)(3), Applicants are presumptively classified as non-dominant on this route.
