Foreign Carrier Affiliation Notification

Pursuant to Section 63.11 of the Commission's rules, AT&T Corp. and the other U.S. international carrier affiliates of AT&T Inc. listed below (collectively, "AT&T") hereby submit this foreign carrier affiliation notification to update the Commission's records concerning their affiliations with carriers in Japan. Answer to Question 10

This notification does not result from an acquisition. AT&T submits this notification to update the Commission's records to include AT&T Japan LLC as one of its foreign carrier affiliates in Japan. AT&T Japan LLC holds a notification license authorizing the provision of resold telecommunications services, but makes all customer sales through its wholly owned subsidiary, AT&T Japan KK (formerly AT&T Global Network Services Japan KK), which also holds a notification license authorizing the provision of resold telecommunications services. AT&T Japan LLC will shortly begin contracting directly with customers, and AT&T Japan KK will cease all sales activities.

Answer to Questions 12 and 16

AT&T certifies that Japan is a WTO member country.¹ AT&T Japan LLC does not own facilities in Japan.

Pursuant to Section 63.10 of the Commission's rules, 47 C.F.R. Sect. 63.10, the above-listed U.S. international carrier affiliates of AT&T continue to qualify for non-dominant classification on the route between the U.S. and Japan because AT&T Japan

LLC has no market power on the foreign end of this route. AT&T Japan LLC has market shares under 50 percent in all relevant markets on the foreign end of the U.S.-Japan route, including the international transport and local access markets in Japan, and is not listed on the Commission's List of Foreign Telecommunications Carriers that are Presumed to Possess Market Power in Foreign Telecommunications Markets. *See* Public Notice, *The International Bureau Revises and Reissues the Commission's List of Foreign Telecommunications Carriers that are Presumed to Possess Market Power in Foreign Telecommunications Markets*, Jan. 26, 2007, http://hraunfoss.fcc.gov/edocs_public/attachmatch/DA-07-233A1.pdf. Accordingly, pursuant to Section 63.10(a)(3), the above-listed U.S. international carrier affiliates of AT&T are presumptively classified as non-dominant on this route.

AT&T Japan LLC is authorized to provide resold telecommunications services to the public in Japan.

BellSouth International, LLC holds facilities-based and resale authority for service originating out of region (ITC-214-19971017-00638) and was a part of the consortium that received Section 214 authority to construct, acquire, and operate capacity in the MAYA-1 cable. *See* ITC-214-19990325-00153.

BellSouth Long Distance, Inc. holds global or limited global facilities-based and resale authorizations for service originating both in region, *see, e.g.*, ITC-214-20020628-00328 (facilities-based and resale services originating in Alabama, Kentucky, Mississippi, North Carolina, and South Carolina), and out of region, *see, e.g.*, ITC-214-19990218-00144 (facilities-based and resale services originating out of region); ITC-214-19970122-00039 (resale services originating out of region).

Centennial Communications Corp. holds global or limited global facilities-based and resale authorizations to provide international services. *See* ITC-214-20000817-00545 (global or limited global facilities-based); ITC-214-19970923-00579 (global resale service).

SBC Long Distance, LLC holds global authority to provide all facilities-based and resale services, both out of region, *see, e.g.*, ITC-214-19971108-00689 (Previous File No. ITC-97-770) (facilities-based services originating out of region); ITC-214-19960906-00422 (Previous File No. ITC-96-497) (resale services originating out of region), and in region, *see, e.g.*, ITC-214-20001130-00713 (facilities-based and resale services originating in Kansas and Oklahoma).

SNET America, Inc. holds authority to resell private line and switched services. *See* ITC-214-19960223-00083 (Previous File No. ITC-96-172) (private line services); ITC-95-145 (switched services).

SNET Diversified Group, Inc. holds authority to provide global resale service. *See* ITC-214-19960917-00451 (Previous File No. ITC-96-538).

TCG America, Inc. is authorized to provide international facilities-based and resale services to all countries. *See* ITC-214-19970814-00493 (Previous File Number ITC-97-506).

TCG New Jersey, Inc. holds an authorization to provide international resale services. *See* ITC-214-19890926-00004 (Previous File No. ITC-90-003).

TC Systems, Inc. holds FCC global authority to provide international switched resale services. *See* ITC-214-19951212-0056 (Previous File Number ITC-96-002).
