Question 10 – Late notification

The Company requests a waiver of the requirement that carriers notify the FCC of foreign affiliations within thirty (30) days after closing. Following its late August 2021 acquisition by Stonepeak Associates IV LLC and its affiliates, the Company inadvertently missed the deadline for this filing by approximately two weeks. The Company notes that it clearly qualifies for continued nondominant treatment on the routes between the U.S. and the above-listed countries but apologies for any inconvenience resulting from its untimely notification.

Question 12.c.1 – Non-dominant carrier demonstration

The Company is currently regulated as non-dominant on the routes between the U.S. and the above-listed countries. The Company asks that it continue to be regulated as a non-dominant carrier on each of these routes. Continued non-dominant treatment is appropriate on these routes because the Company's foreign carrier affiliates in the above-listed countries each lack a 50 percent market share in the international transport and local access market. Currently, each of the Company's new foreign carrier affiliates holds significantly less than a 50-percent market share in the international transport and local access markets in its respective country. Moreover, none of the foreign affiliates has any ability to discriminate against unaffiliated U.S. international carriers through the control of bottleneck services or facilities in its respective international market or appears on the Commission's list of foreign telecommunications carriers presumed to possess market power in foreign telecommunications markets.² Accordingly, these foreign-
