Dear Ms. Dortch:

Puerto Rico Telephone Company, Inc., by its counsel, hereby amends the authority requested in its above-captioned Petition for Declaratory Ruling. Specifically, PRTC revises its request so as to seek advance authority only for the following:

- Approval for Mr. Carlos Slim Helú and certain members of his family (the “Slim Family”) to hold up to and including a 75% equity interest in América Móvil, S.A.B. de C.V. (“América Móvil”), the parent company of PRTC; and
- Approval for the Slim Family to hold up to and including a 95% voting interest in América Móvil.¹

PRTC understands that the above Slim Family ownership limits are consistent with the recommendations made by Team Telecom through its consultative process with the FCC.

¹ PRTC no longer seeks advance Section 310(b) authority for subsequently formed or acquired subsidiaries or affiliates. PRTC also no longer seeks advance authority for new non-U.S.-organized entities that may be subsequently added to the vertical chain of ownership of PRTC. Finally, PRTC no longer seeks advance authority for non-U.S. entities with a direct or indirect controlling interest in PRTC’s controlling U.S. parent to subsequently increase such interests, except as noted above for the Slim Family.
