Dear Mr. Carlin, Ms. Takai, & Mr. Heyman,

This Letter of Assurances outlines the commitments being made by AB License Co LLC ("AB License"), a wholly-owned subsidiary of AB Spectrum LLC, to the U.S. Department of Justice ("DOJ"), the U.S. Department of Defense ("DOD") and U.S. Department of Homeland Security ("DHS"), ("the USG Parties") in order to address national security, law enforcement, and public safety concerns raised with regard to AB License's petition for declaratory ruling to the Federal Communications Commission ("FCC")¹ asking the FCC to allow AB License to exceed the 25% statutory benchmark set forth in section 310(b)(4) of the Communications Act of 1934, as amended, in connection with ten A-Block 700 MHz licenses, seven licenses under a pending

application seeking FCC consent to assign licenses from Cox TMI Wireless, LLC, to AB License,² and three licenses that have already been transferred to AB License.³

Within seven (7) business days of the execution of this Letter of Assurances, AB License shall provide the USG Parties with a list of all Telecommunications Network Equipment currently deployed, or intended to be deployed, on its telecommunications network, including but not limited to: hardware, software, and network management equipment or applications. In the event that the USG Parties object to specific Telecommunications Network Equipment, the USG Parties shall notify AB License in writing within 7 business days of confirmation of receipt of the Telecommunications Network Equipment list from AB License. Any such Telecommunications Network Equipment shall be referred to as "Objectionable Telecommunications Network Equipment." AB License agrees that Objectionable Telecommunications Network Equipment shall not be connected in any manner to any network or facilities operated by AB License, or any other entity on its behalf, and that such Objectionable Telecommunications Network Equipment shall not be used to provide any telecommunications services to any entity in connection with AB License's telecommunications network and facilities.

After the initial Telecommunications Network Equipment list provided in connection with the execution of this Letter of Assurances, AB License shall, on an annual basis, provide an updated list to the USG parties for review and non-objection. In the event the USG Parties object in writing within thirty (30) days to Telecommunications Network Equipment included on the updated list, any such equipment shall be treated as Objectionable Telecommunications Network Equipment. In the event that AB License plans to deploy any new Telecommunications Network Equipment (i.e. Telecommunications Network Equipment that has not previously been identified in a list provided to the USG Parties), it shall notify the USG Parties at least thirty (30) days in advance of proposed deployment. In the event the USG Parties object in writing within thirty (30) days to proposed Telecommunications Network Equipment, any such equipment shall be treated as Objectionable Telecommunications Network Equipment for purposes of this Letter of Assurances and handled in the same manner as set forth above.

Upon execution of this Letter of Assurances, AB License agrees to designate and maintain a Security Officer, and to provide the USG Parties with personally identifiable information for the designee. The Security Officer will be responsible for serving as a point of contact within the United States with the authority and responsibility for overseeing AB License's compliance with this Letter of Assurances. In the event that the USG Parties object to the proposed Security Officer, the USG Parties shall notify AB License in writing within thirty (30) days. AB License will notify the USG Parties of any change in the Security Officer within five (5) days of such change. In the event that the USG Parties object to the proposed change, the USG Parties shall notify AB License in writing within thirty (30) days. AB License shall cooperate with any request by a U.S. Government authority that a background check or security clearance process be completed for a designated Security Officer. The Security Officer shall be responsible for

certifying annually to the USG Parties that AB License is compliant with the terms of the Letter of Assurances.

AB License agrees that upon reasonable notice, the USG Parties may visit AB License's facilities and offices, or those operated on its behalf, to conduct on-site reviews concerning the implementation of the terms of this Letter of Assurances and may require unimpeded access to information concerning technical, physical, management, or other security measures to verify compliance with the terms of this Letter of Assurances. AB License will negotiate in good faith to resolve any national security, law enforcement, or public safety concerns the USG Parties may raise with respect to the AB License Telecommunications Network Equipment, or security practices.

AB License understands that, upon execution of this letter by an authorized representative or attorney for AB License, USG Parties shall notify the FCC that the USG Parties have no objection to the FCC's grant of AB License's pending application.
