Dear Ms. Dortch,

Enclosed please find additional information in connection with Verizon's September 6, 2013, Petition for Declaratory Ruling (the "Petition").

Exhibit 1 contains a list of those entities identified in Appendix A to the Petition that hold common carrier licenses and their associated FRNs and for which Verizon seeks the declaratory ruling. For purposes of this Petition, please use my contact information as the point of contact for each of the entities in Appendix A.¹

Exhibits 2 and 3 contain additional organizational charts relating to Verizon Communications Inc. and to the entities identified in Appendix A to the Petition. For the purposes of completeness, these charts may include additional entities not included in the list in Exhibit 1.

Charts 1 and 2 of Exhibit 2 identify the Cellco ownership chain. This chain shows the existing 55 percent interest in Cellco that is currently and will post-transaction continue to be held by Verizon Communications as well as the 45 percent interest in Cellco that Verizon

¹ The Petition was filed pursuant to 47 U.S.C. § 310(b)(4) of the Communications Act of 1934 on behalf of the post-transaction Verizon Communications Inc. subsidiary licensees holding common carrier radio licenses. Upon reviewing the Verizon subsidiaries, we have not identified any that would require forbearance under 47 U.S.C. § 310(b)(3). However, to the extent the Commission believes that 47 U.S.C. § 310(b)(3) is also applicable to certain licensees, Verizon asks that it be granted forbearance from the provisions of section 310(b)(3) in accordance with the Commission's foreign ownership forbearance order. *See In the Matter of Review of Foreign Ownership Policies for Common Carrier and Aeronautical Radio Licensees under section 310(b)(4) of the Communications Act of 1934, as Amended*, First Report and Order, FCC 12-93 (Rel. Aug. 17, 2012).

Communications is acquiring. The charts also show the intermediate entities for each ownership stream. Chart 3 of Exhibit 2 shows the ownership for those Appendix A entities which have been, and post-transaction will continue to be, directly or indirectly owned by Verizon Communications Inc. (the “Pre-existing Verizon Licensees”).

Exhibit 3 shows the organizational charts for Cellco subsidiaries and affiliate entities in which Vodafone pre-transaction has an ownership interest that will be transferred to Verizon Communications Inc. pursuant to the transaction (“Pre-existing Cellco Licensees”).²
