T-Mobile US, Inc. ("T-Mobile US"), by its undersigned counsel, hereby provides additional information in connection with the above-referenced Petition. T-Mobile US is seeking a declaratory ruling under Section 310(b)(4) of the Communications Act that it would not serve the public interest to prohibit foreign ownership in T-Mobile US of more than 25 percent.

First, T-Mobile US provides an updated Appendix A, which lists T-Mobile US's controlled affiliates and subsidiaries holding radio licenses.

Second, T-Mobile US provides updated Appendix B charts, which depict T-Mobile US's ownership before and after the proposed corporate restructuring described in the pending Petition.




