
**CERTIFICATION OF JOHANNES GOTTSCHALK
PURSUANT TO SECTION 1.991 OF THE RULES**

1. My name is Johannes (Jean) Gottschalk. I am the President of both Telecom North America, Inc. ("Tel-NA") and Telecom North America Mobile, Inc. ("Tel-NA Mobile"). I have read and approved the filing of the Petition for Declaratory Ruling, File No. ISP-PDR-20150605-00004 ("PDR"), filed jointly by Tel-NA and Tel-NA Mobile via IBFS on June 5, 2015.

2. Attached hereto are three additional charts responsive to Section 1.991(h) of the Rules. The first chart is the ownership of Tel-NA as it was approved in FCC File Nos. ISP-PDR-20131213-00012 and ISP-PDR-20140502-00002 (collectively, "Knowroaming"). The second chart is the current ownership of Tel-NA after Knowroaming's April 28, 2015 acquisition of the interest formerly held by Mr. Hervé Andrieu. The third chart is the ownership of Tel-NA as it would be at some time in the future if Knowroaming increased its ownership to 100%, a transaction for which we are seeking pre-approval at this time, so that if we chose to engage in that transaction, we could consummate first and notify the FCC and Team Telecom immediately afterward. In each case (previously approved, current, and potential future), the foreign ownership of Tel-NA (and therefore the indirect ownership of its wholly-owned subsidiary, Tel-NA Mobile) is and would remain at 100%.

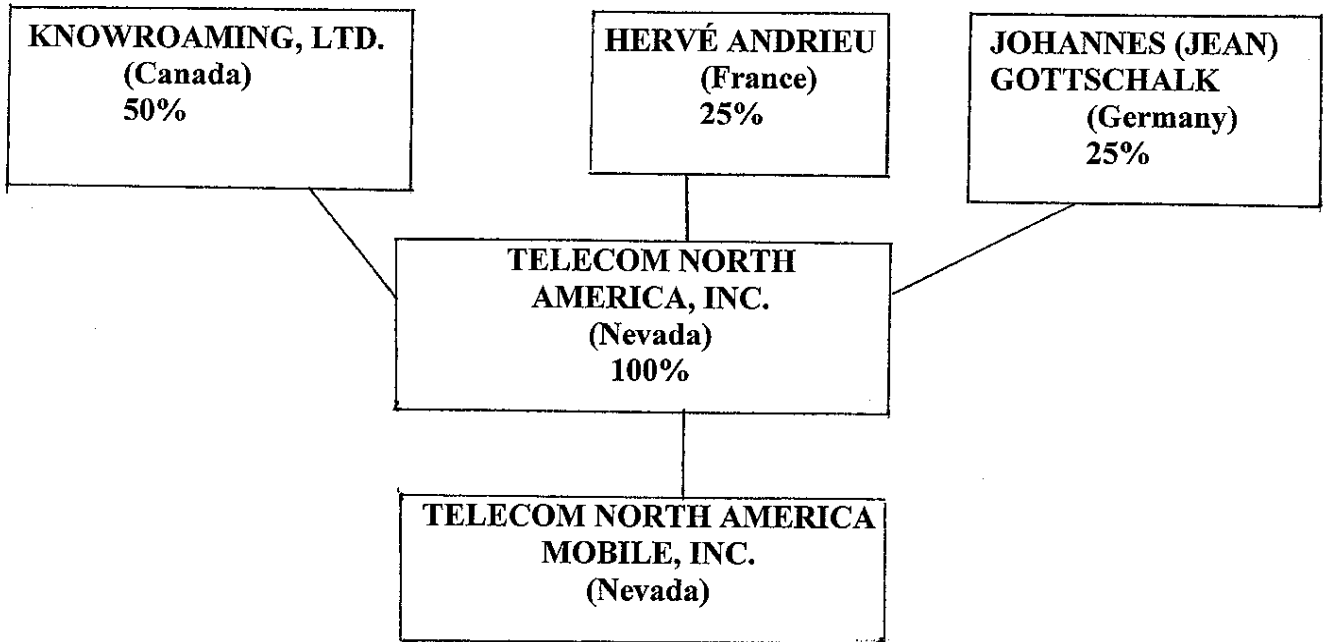

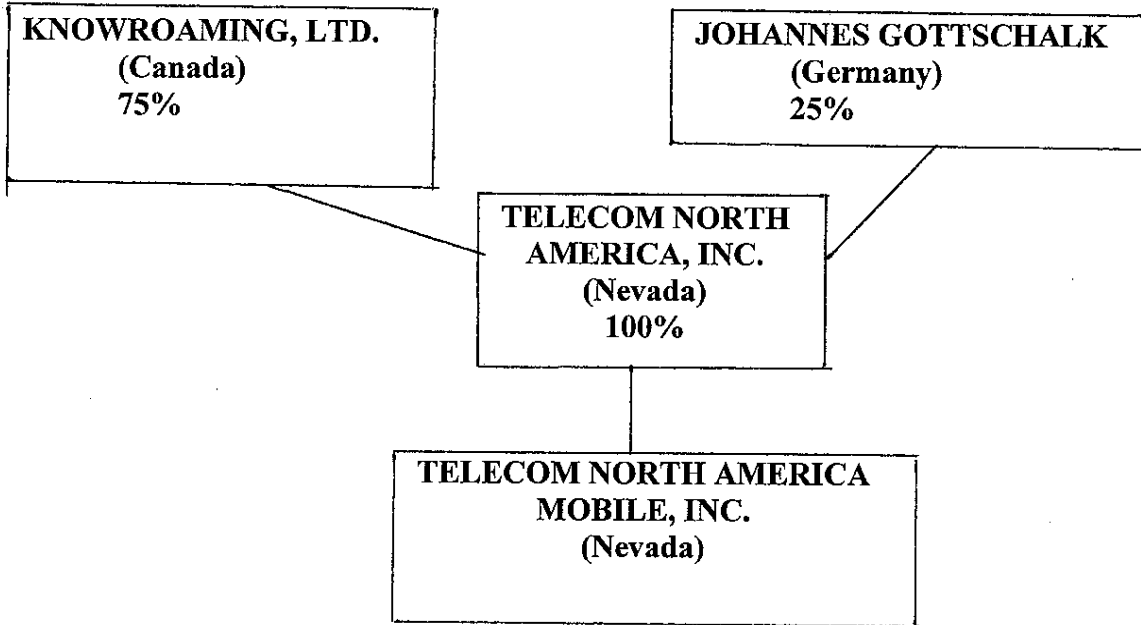

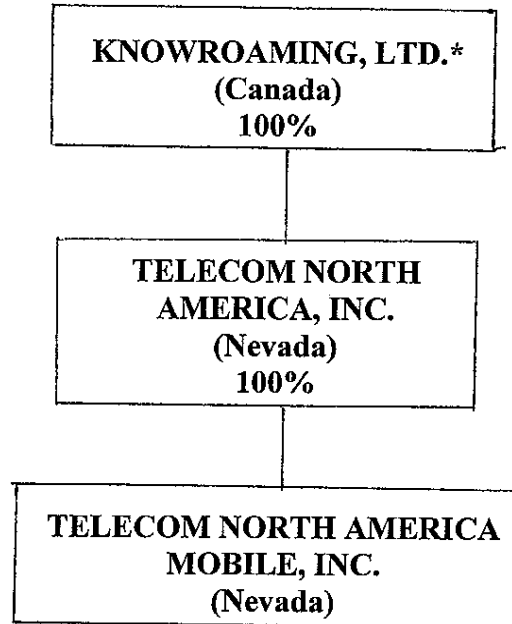
