#### REVISED PETITION FOR DECLARATORY RULING

Pursuant to 47 U.S.C. §310(b)(4) and 47 C.F.R. §1.5000(a)(1), Liberty Latin America Ltd. ("LLA") respectfully petitions the Federal Communications Commission ("FCC" or "Commission") for a declaratory ruling that it would not serve the public interest to prohibit LLA—an entity organized under the laws of Bermuda, but majority-owned and controlled by U.S. persons—from acquiring ultimate indirect ownership and control of two FCC licensee entities that are currently wholly-owned by AT&T Inc. ("AT&T") in the proposed transaction described herein.

LLA submits this petition in connection with applications seeking FCC consent to the transfer of control of AT&T Mobility Puerto Rico Inc. ("AT&T Mobility PR") and AT&T Mobility USVI Inc. ("AT&T Mobility USVI") from AT&T to Leo Cable LP ("Leo Cable"), a Delaware limited partnership and an indirect, wholly-owned subsidiary of LLA, and ultimately to LLA.<sup>1</sup> Pursuant to a Stock Purchase Agreement dated October 9, 2019, and subject to

regulatory approval, Leo Cable has agreed to acquire all of the outstanding capital stock of Beach Holding Corporation ("Beach") from AT&T Corp., AT&T International Holdings, LLC, and SBC Telecom, Inc. Beach holds all of the outstanding capital stock of FCC licensee subsidiaries AT&T Mobility PR and AT&T Mobility USVI.

LLA's shares are publicly traded on the NASDAQ Stock Exchange, and U.S. persons own over 80 percent of LLA's aggregate voting interests, and over 67 percent of LLA's aggregate outstanding equity. Approval of this petition will facilitate significant transaction-specific benefits resulting from LLA's proposed transaction with AT&T. By combining the complementary businesses of LLA's wholly-owned subsidiary Liberty Cablevision of Puerto Rico LLC ("LCPR") with AT&T Mobility PR and AT&T Mobility USVI, LCPR will have the facilities and operations to provide mobile wireless services in Puerto Rico and the U.S. Virgin Islands ("USVI"). The transaction therefore will result in important public interest benefits for consumers in Puerto Rico and USVI.<sup>2</sup> Given these meaningful transaction-specific benefits and the majority ownership and control of LLA by U.S. persons, it would not serve the public interest to prohibit LLA's ultimate ownership and control of the licensee subsidiaries based solely upon LLA's organization in Bermuda.

#### **BACKGROUND**

LLA, a Bermuda company limited by shares, provides communications and entertainment services in Chile, Puerto Rico, the Caribbean and other parts of Latin America, including video, broadband internet, telephony and mobile services. LLA's shares are publicly-traded on the NASDAQ Stock Exchange, and it maintains executive offices in Denver, Colorado and certain network operations and facilities in Miami, Florida and in

Puerto Rico. LLA is a public company controlled by its Board of Directors, who are elected by its shareholders.

AT&T Mobility PR and AT&T Mobility USVI provide mobile wireless voice and mobile wireless data communications services to residential and business customers in Puerto Rico and USVI, as well as wireline internet, private data, VoIP, TDM voice, data center, and associated services to certain business customers located in Puerto Rico. AT&T Mobility PR and AT&T Mobility USVI hold numerous FCC wireless licenses and international section 214 authorizations as set forth in Schedule 1.

The following existing wholly-owned subsidiaries of LLA hold certain non-Title III FCC licenses and authorizations: A.SurNet, Inc., ARCOS-1 USA, Inc., Columbus Networks Puerto Rico, Inc., Columbus Networks Telecommunications Services USA, Inc., Columbus Networks USA, Inc., CWC New Cayman Limited and LCPR. LCPR is the largest cable operator in Puerto Rico, passing over one million homes or approximately 85 percent of the households in Puerto Rico. LCPR currently provides: (1) broadband internet services to approximately 340,000 customers; (2) video services to approximately 220,000 customers; and (3) fixed line telephony to approximately 205,000 customers.

#### PUBLIC INTEREST SHOWING

LLA respectfully submits that it would not serve the public interest to prohibit LLA's proposed ultimate ownership and control of AT&T Mobility PR and AT&T Mobility USVI based solely upon LLA's organization under Bermuda law. LLA's shares are publicly-traded on the NASDAQ Stock Market, and it maintains executive offices in Denver, Colorado and certain network facilities and operations in Miami, Florida and Puerto Rico. LLA's recent analysis of its share ownership analysis confirms that U.S. persons hold more than 80 percent

of LLA's voting interests. Specifically, LLA has determined that U.S. persons own: (1) 37,547,625 Class A<sup>3</sup> Common Shares (approximately 80 percent of total Class A shares outstanding); and (2) 1,865,201 Class B<sup>4</sup> Common Shares (approximately 96 percent of total Class B shares outstanding). Thus, on an aggregate basis, U.S. persons hold approximately 83 percent of LLA's voting interests. With respect to equity ownership, the analysis determined that, of the total 181,064,520 outstanding common shares of LLA (Classes A, B and C<sup>5</sup>), 122,821,717 shares are owned by U.S. persons. U.S. persons therefore own 67.8 percent of LLA's aggregate outstanding equity.

LLA reviewed the following information to estimate the relative proportions of U.S. domestic and foreign beneficial owners and holders of equity and voting interests in LLA:

- Information recorded in LLA's share register regarding the registered owners of Class A Common Shares provided by Computershare Trust Company, N.A., which serves as LLA's registrar and transfer agent.
- Information regarding the share ownership of LLA's directors and officers, as disclosed in LLA's Proxy Statement for its 2019 Annual General Meeting of Shareholders, filed with the U.S. Securities and Exchange Commission ("SEC") on April 3, 2019 ("2019 Proxy Statement").
- The information publicly disclosed by each person or entity that holds more than five percent of LLA's outstanding voting securities pursuant to Section 13(d) and 13(g) of the Securities Exchange Act of 1934 ("Exchange Act") and the SEC's rules promulgated thereunder, as reflected in such holders' Schedule 13D or 13G filings with the SEC.
- Geographical ownership analyses of the Class A Common Shares held in "street name" provided by Mediant Communications Inc. and Broadridge Financial Solutions, Inc., which provide investor communications and related services to LLA and to the broker/dealers, banks and other financial institutions whose customers hold LLA's Class A Common Shares.

- Listings of non-objecting beneficial owners ("NOBOs") of the Class A Shares and the Class C Shares, including the names, addresses and share positions of the NOBOs.
- The listing of shareholders entitled to vote at LLA's 2019 Annual General Meeting of Shareholders.

The FCC treats Bermuda, LLA's place of organization, as a member of the World Trade Organization ("WTO").<sup>6</sup> The United States and Bermuda have been allies and trading partners since the 1700's, and maintain strong government and commercial ties today.<sup>7</sup> In addition, the FCC has approved 100 percent ownership of a company holding Title II authorizations and Title III licenses by a Bermuda company.<sup>8</sup>

Completion of the proposed transaction between LLA and AT&T also will serve the public interest. The comprehensive public interest statement included with lead wireless application File No. 0008836370 sets forth in detail the following public interest benefits that LLA anticipates will result from the proposed transaction:

- Enhancing network resiliency and redundancy in Puerto Rico and USVI through burying substantial portions of LCPR's core network in AT&T Mobility PR's conduit and having alternative fiber routes in and to Puerto Rico and USVI;
- Increasing competition to the ILECs in Puerto Rico and USVI by enabling LCPR to provide a "quad play" of communications services to consumers in Puerto Rico, improving the quality and reliability of both fixed and wireless services to consumers, and potentially deploying fixed services in USVI;

- Optimizing the mobile network and its operation in Puerto Rico by providing wireline backhaul through LCPR's network and increasing network redundancy and improving operations, including better frequency coordination between the mobile networks in the British Virgin Islands and USVI; and
- Intensifying the local focus for wireless services in Puerto Rico and USVI through experienced local management and increased local facilities.

These transaction-specific benefits are discussed in the Public Interest Statement at 10-17.

Grant of this declaratory ruling petition also will facilitate LLA's access to domestic and foreign sources of capital as it implements these transaction-specific benefits. Specifically, LLA expects that it would be able to accept strategic foreign investment and access foreign capital at potentially lower costs following grant of this petition. As the FCC has recognized, "foreign investment has been and will continue to be an important source of financing for U.S. telecommunications companies, fostering technical innovation, economic growth, and job creation." Finally, issuance of the requested declaratory ruling will promote competition with Puerto Rico Telephone Company ("Claro PR"), the ILEC and wireless services provider in Puerto Rico. Claro PR is a wholly-owned subsidiary of América Móvil, S.A.B. de C.V., which is organized under the laws of Mexico, and has been authorized by the FCC to accept foreign investment since 2007.<sup>10</sup>

Genesis Asset Managers, LLP ("Genesis"), an investment advisor to institutional investors and in-house pooled funds for institutional advisors, organized under the laws of Delaware with a principal business address in Guernsey, Channel Islands, holds 8.4 percent of LLA's voting power. Based upon Genesis's Schedule 13G for the year ended December 31, 2018, filed with the SEC on January 25, 2019, Genesis reports its beneficial ownership interest in LLA pursuant to Exchange Act Rule 13d-1(b). LLA therefore is exempt from the requirement in Section 1.5001(i) of the Rules to request specific approval for the ownership interest held by Genesis in LLA because such interest in LLA currently is no greater than 10 percent. See 47 C.F.R. §1.5001(i)(3).

However, LLA requests specific approval for Genesis to exceed the 10 percent ownership threshold for institutional investors up to and including a non-controlling equity and voting interest of 15 percent. Because LLA is a public company and Genesis presently holds an 8.4% voting interest, LLA seeks such approval to accommodate ordinary-course stock purchases by Genesis which could cause it to exceed the 10 percent threshold.

#### CONCLUSION

LLA respectfully requests approval of this petition for declaratory ruling to permit the indirect, ultimate ownership of AT&T Mobility PR and AT&T Mobility USVI by LLA. As demonstrated above and in the comprehensive public interest statement filed with the transfer of control applications, the transaction between LLA and AT&T will yield significant transaction-specific benefits for consumers in Puerto Rico and the USVI. In view of these

meaningful transaction-specific benefits, it would not serve the public interest to deny this petition based upon LLA's place of organization in Bermuda, a close ally and trading partner of the U.S., or LLA's aggregate equity ownership, when U.S. persons hold approximately 83 percent of LLA's aggregate voting interests.


