# PETITION OF PACIFIC TELECOM INC. AND PTI PACIFICA INC. FOR NEW FOREIGN OWNERSHIP DECLARATORY RULING UNDER SECTION 310(b)(4) OF THE COMMUNICATIONS ACT OF 1934, AS AMENDED

Pacific Telecom Inc. ("Pacific Telecom" or "PTI") and its indirect wholly-owned subsidiary PTI Pacifica Inc. ("PTI Pacifica"), by their attorneys, hereby files a petition for a new declaratory ruling under Section 310(b)(4) of the Communications Act of 1934, as amended (the Act"), to allow PTI Pacifica, an entity with 100 percent indirect foreign ownership, to control any type of FCC common carrier license in any geographic area in accordance with Part 1, Subpart T of the Commission's rules.<sup>1</sup>

# I. THE FCC ALREADY PREVIOUSLY GRANTED PTI PACIFICA FOREIGN OWNERSHIP AUTHORIZATION TO HOLD SEVERAL TYPES OF COMMON CARRIER LICENSES

PTI Pacifica is incorporated in the Commonwealth of the Northern Mariana Islands ("CNMI"), a self-governing commonwealth in political union with and under the sovereignty of the United States of America. PTI Pacifica is directly owned (100 percent) by The Micronesian Telecommunications Corporation ("MTC"), also a CNMI corporation, which is the incumbent

local exchange carrier in CNMI.<sup>2</sup> MTC in turn is owned (100 percent) by PTI, also a CNMI corporation.

PTI is owned 85 percent by Prospector Pacific Investments Inc. ("PPII"), a CNMI corporation, and 15 percent by SK Telecom Co. Ltd., a publicly-traded South Korea corporation listed on the Korea Stock Exchange. PPII is owned 100 percent by Citadel Pacific Holdings Ltd. ("CPHL"), a Cayman Island corporation formerly known as Prospector Investments Ltd. CPHL primarily is owned by two citizens of the Philippines, Ricardo C. Delgado (53.99 percent) and his son Jose Ricardo Delgado (36.25 percent). Classroom Investments Inc. ("CII"), a Canadian corporation, holds 9.76 percent of CPHL. CCI is owned 100 percent by the Ontario Teachers' Pension Plan, a Canadian entity. No other party holds a 10 percent or greater, or a controlling, direct or indirect ownership interest in CPHL (or PTI Pacifica). An organizational diagram is provided in Exhibit A to this petition.

The FCC on five occasions has issued foreign ownership declaratory rulings authorizing PTI's wholly-owned indirect subsidiary PTI Pacifica to hold different types of FCC common carrier licenses. The FCC's 2003 ruling covered a cellular license and a common carrier earth station license in the CNMI.<sup>3</sup> A 2006 ruling approved a PCS license covering both CNMI and Guam.<sup>4</sup> A 2008 ruling approved the acquisition at auction of a 700 MHz license covering CNMI and Guam.<sup>5</sup> A 2009 ruling approved the acquisition of common carrier LMDS and earth station

licenses in CNMI and Guam.<sup>6</sup> A ruling in 2010 authorized PTI to accept up to a 40 percent indirect, non-controlling equity and voting interest by a specified foreign investor.<sup>7</sup> In 2019 PTI and PTI Pacifica filed a petition to extend its foreign ownership authorization, to the extent necessary, to any Upper Microwave Flexible Use Service ("UMFUS") licenses that PTI Pacifica might win in Auction 103.<sup>8</sup> The latter petition is still pending.

Prospectively, PTI Pacifica seeks authority for all types of FCC licenses for which PTI Pacifica has not previously received service-specific approval and for all geographic areas.

Petitioners request application of the routine terms and conditions set forth in Section 1.5004 of the Commission's rules. Petitioners request advance approval for the currently controlling individual, Ricardo C. Delgado, and currently controlling foreign company Citadel Pacific Ltd. to increase their indirect interests in PTI

Pacifica up to 100 percent of the indirect equity and voting interests. Advance approval is also requested for Jose Ricardo Delgado to increase his indirect interests in PTI Pacifica up to and including a 49.9 percent non-controlling indirect equity and/or voting interest in PTI Pacifica and for Classroom Investments Inc., Ontario Teachers' Pension Plan, and SK Telecom Co. Ltd. to increase its respective indirect interest in PTI Pacifica up to and including a 49.9 percent non-controlling indirect equity and/or voting interests.

#### III. GRANT OF THIS PETITION IS IN THE PUBLIC INTEREST

The Commission has recognized that foreign investment has been and will continue to be an important source of financing for U.S. telecommunications companies, fostering technical innovation, economic growth, and job creation. For almost two decades, the Commission has consistently permitted non-U.S. individuals and entities to hold up to 100 percent of the equity and voting power in holders of FCC licenses subject to Section 310(b)(4) of the Act. The FCC has granted PTI foreign ownership authorizations up to 100 percent on five prior occasions. The public interest will be served by the Commission issuing a declaratory ruling to allow PTI Pacifica to enter into spectrum leases or acquire additional common carrier licenses for which PTI Pacifica has not previously received service-specific approval.

#### IV. REQUEST FOR NATIONAL SECURITY AGREEMENT CONDITION

Petitioners request that the Commission condition grant of the requested authority on PTI's continued compliance with the national security agreement between PTI and certain

Executive Branch agencies, which was incorporated as an appendix to the 2003 Acquisition Order.<sup>13</sup>

#### V. CONCLUSION

For the foregoing reasons, the Commission should issue a declaratory ruling under Part 1, Subpart T, of its rules that the public interest would not be served by prohibiting PTI Pacifica from entering into spectrum leases or acquiring common carrier licenses for which PTI Pacifica has not previously received service-specific approval.


#### **INDIRECT OWNERSHIP**

PTI Pacifica Inc., the filer, is incorporated in the U.S. territory of the Commonwealth of the Northern Marianas (CNMI). The filer is directly owned (100%) by The Micronesian Telecommunications Corporation, a CNMI corporation, which in turn is owned (100%) by Pacific Telecom Inc. (PTI) a CNMI corporation.

PTI is owned 85% by Prospector Pacific Investments Inc. (PPII), a CNMI corporation, and 15% by SK Telecom Co. Ltd., a publicly-traded South Korea corporation listed on the Korea Stock Exchange (KRX). PPII is owned 100% by Citadel Pacific Holdings Ltd. (CPHL), a Cayman Island corporation formerly known as Prospector Investments Ltd. CPHL primarily is owned by two citizens of the Philippines, Ricardo C. Delgado (53.99%) and Jose Ricardo Delgado (36.25%). No other party holds a 10% or greater or controlling indirect ownership interest in CPHL (or the filer).
