Dear Ms. Dortch

Pursuant to Section 1.65 of the Commission's rules, Red Fiber Parent LLC ("Red Fiber Parent") supplements the above referenced Petition for Declaratory Ruling ("PDR") under Section 310(b)(4) of the Communications Act of 1934, as amended.

In its supplement filed on March 30, 2021, Red Fiber Parent noted that Cincinnati Bell Inc. ("Cincinnati Bell") recently obtained 56 common carrier priority access licenses (the "Licenses") in Auction 105. Red Fiber Parent and Cincinnati Bell Inc. ("Cincinnati Bell") have filed a transfer of control application with the Wireless Telecommunication Bureau (File No. 0009466407) to include the Licenses in the consent that the parties have sought for the proposed transaction described in the PDR and the other applications pending before the Commission.¹

Cincinnati Bell will complete a *pro forma* assignment of the Licenses to three of its wholly owned subsidiaries at the closing of the transfer of control transaction. Of the 56 total licenses, 13 will be assigned to Hawaiian Telcom Inc. ("HTI"), 12 will be assigned to Cincinnati Bell Extended Territories LLC ("CBET"), and the remaining 31 will be assigned to Cincinnati Bell Telephone Company LLC ("CBT"). Therefore, Cincinnati Bell will remain the controlling U.S. parent for purposes of the Section 310(b)(4) foreign ownership analysis.
