PETITION FOR DECLARATORY RULING

Pursuant to 47 C.F.R. § 1.5000 *et seq.*, Petitioners Conterra Ultra Broadband, LLC (“CUB”), Network USA, LLC (“Network USA”), Detel Wireless, LLC (“Detel” and, together with CUB and Network USA, the “Licensees”), EagleCrest CUB GP Inc. (“EagleCrest CUB GP”), and Draden Investors, LLC (“APG US”)¹ respectfully request that the Commission issue a declaratory ruling finding that indirect foreign investment in the Licensees above the 25-percent benchmark in 47 U.S.C. § 310(b)(4) is in the public interest. Specifically, the Petitioners seek a ruling permitting up to 100-percent indirect aggregate foreign investment (voting and equity) in Licensees, each of which holds common carrier point-to-point microwave licenses. The

Petitioners also request specific approval for certain foreign investors that seek to hold indirectly more than 10 percent of the Licensees' equity and/or hold equity interests that will cause them to be deemed to hold indirectly more than 10 percent of the Licensees' voting rights (or 5 percent, if the investor is unincorporated).² As described more fully below, approval of the proposed indirect foreign investment in Licensees is consistent with Commission policy and precedent finding that foreign investment from all foreign countries (irrespective of World Trade Organization status) serves the public interest by encouraging reciprocal investment opportunities for U.S. companies in those countries.

I. BACKGROUND AND DESCRIPTION OF THE PROPOSED TRANSACTION

The Licensees are wholly-owned subsidiaries of Conterra Ultra Broadband Holdings, Inc. ("CUB Holdings"), which is in turn a wholly-owned subsidiary of CUB Parent, Inc. ("CUB Parent"). CUB Parent is majority owned, and thus controlled, by CSC CUB Holdings, LP, a Delaware limited partnership ("CSC CUB Holdings"), with CSC CUB Holdings owning 75.4 percent of CUB Parent's Class L shares.³ CSC CUB Holdings is controlled by its general partner, Court Square Capital GP III, LLC, a Delaware limited liability company ("CSC GP"). CSC GP also controls, in its role as general partner, the Court Square investment funds ("CSC Funds") that currently hold 84.3 percent of the economic units in CSC CUB Holdings. The remaining 24.6-percent interest in CUB Parent's Class L shares is held by other investors,

including management of CUB Holdings, Licensees' immediate parent. (CUB Holdings' management currently owns all of CUB Parent's Class A shares.) One such investor, EagleCrest CUB LP, a Delaware limited partnership ("EagleCrest CUB") currently holds 8.7-percent of CUB Parent's Class L shares and also holds the remaining 15.7-percent of the economic units in CSC CUB Holdings.

Through a series of simultaneous transactions (the "Proposed Transaction") to be consummated following the satisfaction of various closing conditions, including the grant of various Commission consents and issuance of a declaratory ruling, the following will occur:

- CSC GP will resign as general partner of CSC CUB Holdings and the CSC Funds' equity interests in CSC CUB Holdings will be redeemed through a distribution of CUB Parent shares, with CSC CUB Holdings retaining a direct 25.5-percent voting and economic interest in CUB Parent.
- EagleCrest CUB GP Inc., the general partner of EagleCrest CUB LP, will be appointed as the general partner of CSC CUB Holdings, thus acquiring 100-percent of the voting interest in CSC CUB Holdings.
- EagleCrest CUB LP, which currently holds 8.7 percent of CUB Parent's Class L shares will acquire from the CSC Funds and management investors shares representing an additional 14.9-percent direct voting and equity interest in CUB Parent, bringing its total direct economic and voting interest in CUB Parent (post-recapitalization) to 23.2-percent, and EagleCrest CUB GP's total indirect voting interest in CUB Parent to 48.7-percent.
- APG US, a Delaware limited liability company controlled by its non-member Manager, APG Asset Management US Inc. ("APG Asset Management US"), will

acquire from the CSC Funds and management investors a 49.9-percent voting and economic interest in CUB Parent.

- CUB Holdings management will hold the remaining 1.4-percent voting and economic interest in CUB Parent.

Thus, upon consummation of the Proposed Transaction, the Licensees will no longer be indirectly owned by CSC Funds and controlled by CSC GP. The Licensees will continue to be 100-percent indirectly owned and controlled by CUB Parent. No entity or individual will exercise *de jure control* over CUB Parent. Nevertheless, through a shareholders' agreement by and among CSC CUB Holdings, EagleCrest CUB LP, APG US and CUB Parent, each of EagleCrest CUB GP and APG US will exercise negative control over CUB Parent.

Both EagleCrest CUB GP and APG US's direct U.S. parent, APG Asset Management US, are 100-percent foreign-owned and controlled by entities and individuals from foreign countries, primarily Canada and the Netherlands, as detailed in Exhibit A.

Ultimate operating control of EagleCrest CUB GP is exercised by Fiera Infrastructure Inc., a Canadian federal corporation, whose immediate parent, Fiera Capital Corporation ("Fiera Capital"), an Ontario corporation, is indirectly controlled by Mr. Jean-Guy Desjardins, a Canadian citizen.

Ultimate operating control of APG US is exercised by its direct parent, APG Asset Management US Inc. ("APG Asset Management US"), a Delaware corporation, which itself is ultimately owned and controlled by Stichting Pensioenfond ABP ("SPF ABP"), a Netherlands pension fund.

Please see Exhibit A for a more detailed description of the Licensees' post-close ownership and control structure and diagrams illustrating their ownership structure before and after consummation of the Proposed Transaction.

C. Type of Radio Service Authorization and Associated Applications⁶

Petitioners seek a declaratory ruling to authorize 100-percent indirect foreign ownership in the Licensees, which hold the common carrier point-to-point microwave licenses identified at Exhibit B-1 (CUB), Exhibit B-2 (Network USA), and Exhibit B-3 (Detel).

This Petition is being filed concurrently with applications for the indirect transfer of control of the Licensees' wireless licenses to EagleCrest CUB GP and APG US pursuant to 47 U.S.C. § 310(d) in File Nos. 0009141475 (Lead), 0009147728, 0009141304, 0009141349, and 000914613 and the indirect transfer of control of domestic common carrier transmission facilities pursuant to 47 U.S.C. §214(c).

D. Type of Declaratory Ruling⁷

Petitions seek a declaratory ruling under 47 C.F.R. § 1.5000(a)(1).

E. Direct and Indirect Equity and Voting Interests of 10 Percent or More⁸

Exhibit A provides the requested information for all individual and entities who will, upon consummation of the Proposed Transaction, hold direct or indirect equity or voting interests of 10 percent or more.

F. Estimate of Aggregate Foreign Ownership⁹

Exhibit C provides Petitioners' percentage estimate of the aggregate indirect foreign interests to be held in Licensees upon consummation of the Proposed Transaction, together with a description of the methods used to determine such percentages. Exhibit C further provides a statement addressing the circumstances prompting the filing of this Petition and demonstrating that the grant of the petition would serve the public interest.

G. Description of Ownership and Control Structure¹⁰

As indicated in part I above, Exhibit A provides a description of the ownership and control structure of the Licensees post-consummation of the Proposed Transaction and provides an organizational diagram illustrating that ownership and control structure.

H. Requests for Specific Approval and Requests for Advance Approval¹¹

Petitioners request specific approval for those entities and individuals identified on Exhibit D. Other than such entities and individuals (and the potential co-investment described on Exhibit D), no other foreign interest holder will have a 5-percent (if uninsulated) or 10-percent (if insulated) direct or indirect interest in CUB Parent and Licensees upon consummation of the Proposed Transaction.

III. CONCLUSION

Petitioners respectfully request that the Commission issue a declaratory ruling finding that it is in the public interest to allow indirect foreign ownership in Licensees to exceed the 25-percent benchmark set forth in Section 310(b)(4) and to permit the foreign entities and individuals identified in this Petition to hold greater than 10-percent (or 5-percent if unincorporated) indirect equity and/or voting interests in Licensees.



LICENSEES' POST-CLOSE OWNERSHIP AND CONTROL STRUCTURE

Upon consummation of the Proposed Transaction, the Licensees will remain wholly-owned subsidiaries of Conterra Ultra Broadband Holdings, Inc. (“CUB Holdings”), which in turn will remain a wholly-owned subsidiary of CUB Parent, Inc. (“CUB Parent”), both of which are Delaware entities. Voting and equity interests in CUB Parent will be owned 25.5 percent by CSC CUB Holdings LP (“CSC CUB Holdings”), 23.2 percent by EagleCrest CUB LP (“EagleCrest CUB”) (subject to potential co-investment as described herein), and 49.9 percent by Draden Investors, LLC (“APG US”), all Delaware entities. Management personnel of CUB Holdings will hold the remaining 1.4-percent interest in CUB Parent.

As explained in part I of the Petition, both CSC CUB Holdings and EagleCrest CUB LP will be 100-percent controlled by the same general partner—EagleCrest CUB GP Inc. (“EagleCrest CUB GP”), while APG US is indirectly wholly owned and controlled by Stichting Pensioenfond ABP, a Netherlands pension fund (“SPF ABP”). Through a shareholders’ agreement by and among CSC CUB Holdings, EagleCrest CUB LP, APG US, and CUB Parent, each of EagleCrest CUB GP and APG US will indirectly exercise negative control over CUB Parent.

Ultimate operating control of EagleCrest CUB GP is exercised by Fiera Infrastructure Inc., a Canadian federal corporation (“Fiera”), whose immediate parent, Fiera Capital Corporation (“Fiera Capital”), an Ontario corporation, is indirectly controlled by Mr. Jean-Guy Desjardins, a Canadian citizen.

Ultimate operating control of APG US is exercised by its non-member manager, APG Asset Management US Inc., a Delaware corporation (“AGP Asset Management US”), which

itself is ultimately owned and controlled by SPF ABP. APG US's sole member—and owner of all of the economic interest in APG US—is APG Infrastructure Pool 2020-2021 (“APG Pool 2020-2021”), a Netherlands investment pool that is 99.4-percent owned and controlled by SPF APB. In part I below, Petitioners identify each individual and entity who will hold, upon consummation of the Proposed Transaction, a direct or indirect 10-percent or greater equity and/or voting ownership interest in Licensees, provide the information requested for such interest holders by 47 C.F.R. §1.5001(e), (f) & (g), and explain those interest holders' role (if any) in the management and control of Licensees, EagleCrest CUB GP, and APG.

Please see Attachments 1 and 2 for diagrams illustrating the pre- and post-close ownership structures of Licensees.

1. POST-CLOSE OWNERSHIP STRUCTURE

Upon consummation of the Proposed Transaction, CUB Parent (and thus the Licensees) will have the 10-percent-or-greater direct and indirect voting and equity interest holders identified in parts A and B below. Part A includes the direct interests in CUB Parent to be held by CSC CUB Holdings and EagleCrest CUB LP and all indirect 10-percent-or-greater interests held through those two entities (collectively, “Fiera Group”). Part B includes the direct interest in CUB Parent to be held by APG US and all indirect interests held through APG US (collectively, “APG Group”).

All equity and voting interests are calculated pursuant to 47 C.F.R. § 1.5002(a) and (b), respectively, with voting interests coupled with control (including negative control) treated as interests of 100 percent. Interests identified as attributable interests are indirect interests in Licensees that the holders are deemed to have pursuant to the Commission's rules.

Interest Held: CSC CUB Holdings will hold a 25.5-percent voting and equity interest in CUB Parent.
Attributable Interest: 25.5-percent voting and equity
Role: CSC CUB Holdings, together with its affiliate, EagleCrest CUB LP, will have negative control over CUB Parent, which negative control will be exercised by their general partner, EagleCrest CUB GP Inc.
2. *Name:* **EagleCrest CUB LP**
Place of Organization: Delaware
Type of Organization: limited partnership
Insulation Status: EagleCrest CUB LP’s limited partners, EagleCrest Portfolio Holdings LP, EagleCrest Infrastructure Canada LP, and EagleCrest Infrastructure SCCp (Nos. 4, 5 and 6 below), will be fully insulated pursuant to the standards set forth in 47 C.F.R. § 1.5003. Petitioners will submit a copy of EagleCrest CUB LP’s limited partnership agreement to the Commission on a confidential basis.
Principal Business: investments
Interest Held: EagleCrest CUB LP will hold a 23.2-percent voting and equity interest in CUB Parent, and 100 percent of the outstanding units of CSC CUB Holdings.
Attributable Interest: 23.2-percent voting and equity
Role: EagleCrest CUB LP, together with its affiliate, CSC CUB Holdings LP, will have negative control over CUB Parent, which negative control will be exercised by their general partner, EagleCrest CUB GP Inc.
3. *Name:* **EagleCrest CUB GP Inc. (“EagleCrest CUB GP”)**
Place of Organization: Delaware
Type of Organization: corporation
Principal Business: investment management

Interest Held: As general partner, EagleCrest CUB GP Inc. will hold a 100-percent voting interest in both EagleCrest CUB LP and CSC CUB Holdings.

Attributable Interest: 100-percent voting; 0-percent equity

Role: EagleCrest CUB GP will, in its role as general partner of CSC CUB Holdings and EagleCrest CUB LP, exercise control over the two limited partnerships' combined 48.7-percent voting and equity interest in CUB Parent and thus will exercise negative control over CUB Parent.

4. *Name:* **EagleCrest Portfolio Holdings LP (“EagleCrest Portfolio”)**

Place of Organization: Ontario, Canada

Type of Organization: limited partnership

Insulation Status: The limited partners in EagleCrest Portfolio (nos. 5 and 6 below), are fully insulated pursuant to the standards set forth in 47 C.F.R. 1.5003. Petitioners will submit a copy of EagleCrest Portfolio's limited partnership agreement to the Commission on a confidential basis.

Principal Business: investments

Interest Held: EagleCrest Portfolio holds a 100-percent voting and equity interest in EagleCrest CUB GP. Also, as an insulated limited partner, EagleCrest Portfolio holds a 98-percent equity interest in EagleCrest CUB LP.

Attributable Interest: 100-percent voting; 47.7-percent equity

Role: EagleCrest Portfolio is the entity through which the interests of two investment vehicles, EagleCrest Infrastructure Canada LP and EagleCrest Infrastructure SCSp (nos. 5 and 6 below), are aggregated.

5. *Name:* **EagleCrest Infrastructure Canada LP (“EagleCrest Infrastructure Canada”)**

Place of Organization: Québec, Canada

Type of Organization: limited partnership

Insulation Status: EagleCrest Infrastructure Canada's limited partners (including no. 7 below) are indirectly insulated through EagleCrest Infrastructure's insulated limited partnership interests in EagleCrest Portfolio and EagleCrest CUB LP. EagleCrest Infrastructure Canada's limited partners have certain rights to replace the general partner; however, any exercise of those rights will have no effect on management or control of any downstream entity, including CUB Parent and Licensees. Accordingly, in accord with 47 C.F.R. § 1.5001(i)(3), EagleCrest Infrastructure Canada's limited partners do not and could not have the ability to change or influence control of CUB Parent and Licensees and, under the facts and circumstances, are fully insulated pursuant to 47 C.F.R. § 1.5003.

Principal Business: investments
Interest Held: As a limited partner, EagleCrest Infrastructure Canada holds a 60.16-percent equity interest in EagleCrest Portfolio and will hold a 1-percent equity interest in EagleCrest CUB LP.
Attributable Interest: 100-percent voting; 29-percent equity¹
Role: EagleCrest Infrastructure Canada is a passive investor. EagleCrest Infrastructure Canada will hold an equity interest, with no role in the operations or management of EagleCrest Portfolio or any other downstream entity, including CUB Parent and Licensees. EagleCrest Infrastructure Canada’s general partner is Fiera Infra GP Inc. (no. 13 below).

6. *Name:* **EagleCrest Infrastructure SCSp (“EagleCrest Infrastructure Luxembourg”)**
Place of Organization: Luxembourg
Type of Organization: société en commandite spéciale: similar to a limited partnership

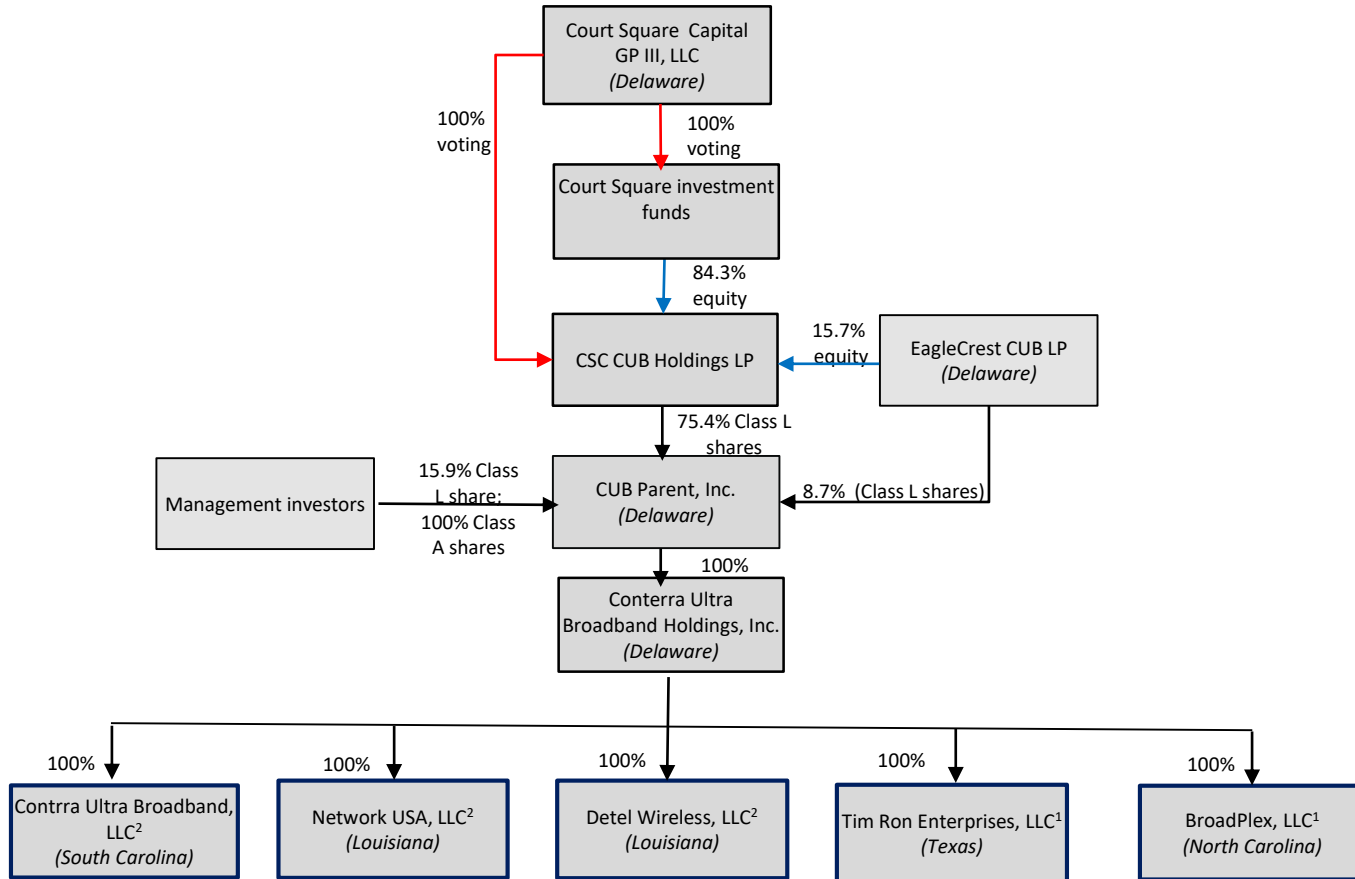

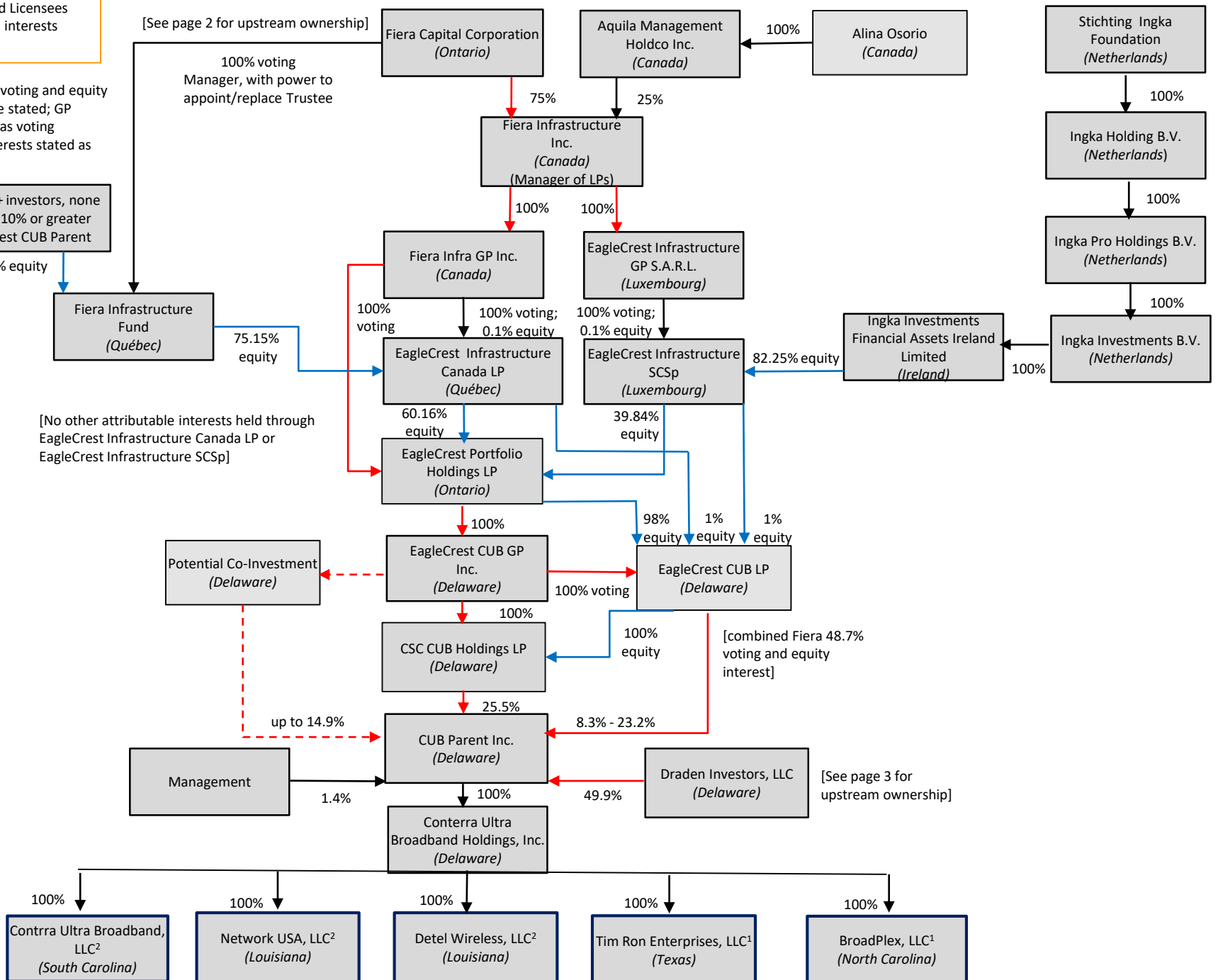

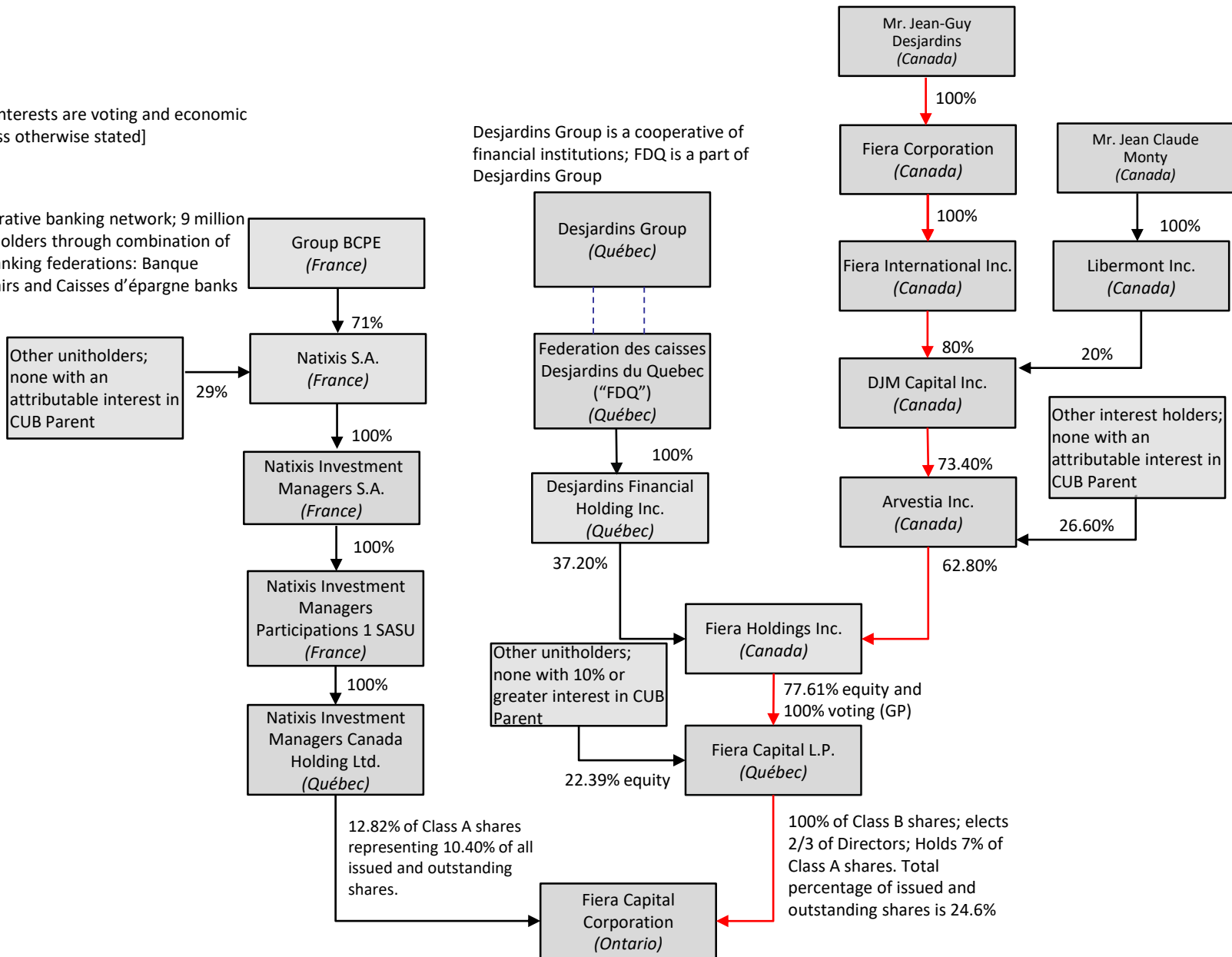


FIERA CAPITAL CORPORATION OWNERSHIP STRUCTURE

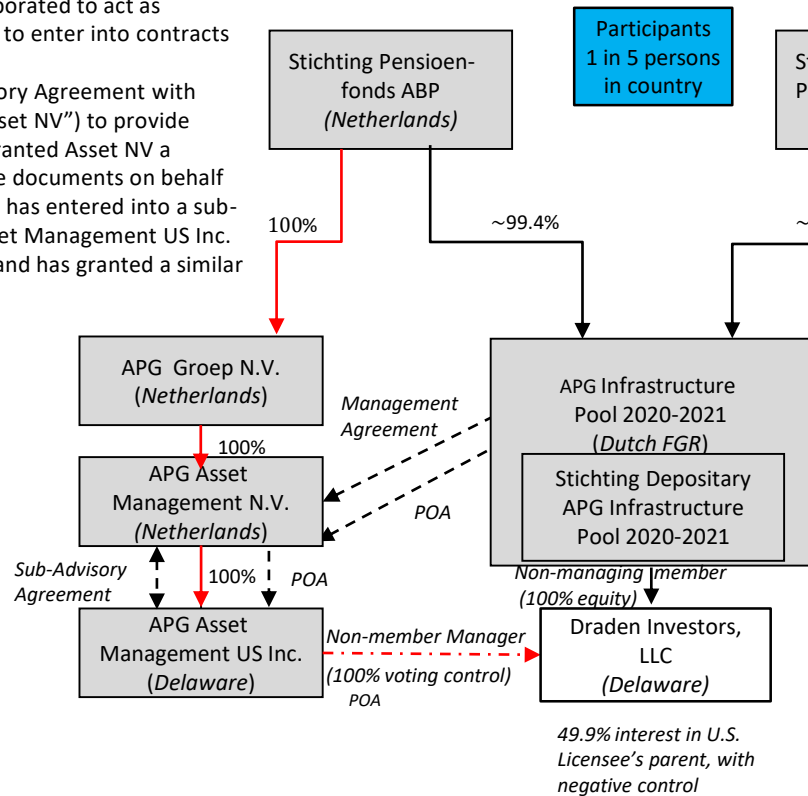

STATEMENT OF CIRCUMSTANCES ESTIMATE OF AGGREGATE FOREIGN INTEREST AND PUBLIC INTEREST STATEMENT

1. STATEMENT OF CIRCUMSTANCES AND ESTIMATE OF AGGREGATE FOREIGN INTEREST

This Petition is submitted in connection with the Proposed Transaction—*i.e.*, the acquisition of indirect interests in Conterra Ultra Broadband, LLC (“CUB”), Network USA, LLC (“Network USA”), Detel Wireless, LLC (“Detel” and, together with CUB and Network USA, the “Licensees”) by EagleCrest CUB GP, LP (“EagleCrest CUB GP”), and Draden Investors, LLC (“APG US”), with each of EagleCrest CUB GP and APG US exercising negative control over CUB Parent and Licensees. Each of EagleCrest CUB GP and APG US are ultimately 100-percent foreign-owned by entities and individuals in Canada and the Netherlands—with additional interests held by entities from France. Petitioners estimate that foreign ownership of its capital stock following a grant of this Petition and approval of the associated transfer-of-control applications would, on an indirect basis, be 100 percent. This estimate is based upon direct inquiry of the entities that will hold direct and/or indirect ownership interests in CUB Parent.

2. GRANT OF THIS PETITION WOULD SERVICE THE PUBLIC INTEREST

The Commission has previously determined that allowing indirect foreign investment in a common carrier radio license above the 25-percent benchmark set forth in 47 U.S.C. § 310(b)(4) services the public interest, regardless of whether the entity or entities holding that interest are from WTO member or non-WTO member countries, by promoting competition in the U.S.

market, thereby promoting the U.S. public interest.¹⁵ At the same time, the Commission stated that it would continue to coordinate with the relevant Executive Branch agencies to ensure that requests to exceed foreign ownership benchmark are consistent with national security, law enforcement, foreign policy, and trade policy concerns.¹⁶

This approach benefits U.S. consumers by encouraging additional competition in the U.S. market, allowing the Commission to prevent anticompetitive conduct in the provision of international services and facilities more effectively, and promoting further opening to U.S. carriers in foreign markets.¹⁷ The Commission has determined that the public interest would be served by permitting foreign ownership, in part, because:

[R]emoving barriers to entry and focusing on competitive safeguards will promote effective competition in the U.S. telecommunications services market by removing unnecessary regulation and barriers to entry that can stifle competition and deprive U.S. consumers of the benefits of lower prices, improved service quality, and service innovations.¹⁸

The Proposed Transaction raises no significant foreign ownership or control issues that would be of interest to the U.S. government with respect to national security, law enforcement, foreign policy, or trade policy concerns, and is in the public interest. This Petition meets all of the requirements of 47 U.S.C. §310(b)(4) and the Commission's rules and policies. Therefore,
