The limited partners of SB Northstar LP are three Delaware limited liability companies, Delaware Project 1 LLC, Delaware Project 2 LLC, and Delaware Project 3 LLC (collectively, the "Delaware Project LLCs"), each of which owns a one-third equity interest in SB Northstar LP.

SB Management Ltd. is the general partner of SB Northstar LP, in which it holds a 100 percent voting and 0 percent equity interest. SB Management Ltd. is 100 percent directly owned by Softbank Group Corp.

Softbank Group Corp. indirectly controls SB Northstar LP through its 100 percent ownership of SB Northstar LP's general partner, SB Management Ltd., and accordingly holds a 10.8 percent indirect voting interest in Sinch AB. Softbank Group Corp. indirectly owns two-thirds of the equity interest in SB Northstar LP through its two-thirds membership interest in each of the Delaware Project LLCs—and accordingly holds a 7.2 percent indirect equity interest in Sinch AB.

Masayoshi Son holds a 26.5 percent voting and equity interest in SoftBank Group Corp., and also indirectly holds one-third of the equity interest in SB Northstar LP through his ownership of one-third of the membership interests in each of the Delaware Project LLCs. SB Northstar LP in turn holds a 10.8 percent direct voting and equity interest in Sinch AB. Thus, Mr. Son's combined indirect equity interest in Sinch AB through his indirect interest in SB Northstar LP (3.6 percent) and direct interest in Softbank Group Corp. (1.9%), is 5.5 percent.
