Re: International Section 214 Authorizations (IB File Nos. ITC-89-099 and ITC-214-19970627-00354 (Old File No. ITC-97-379)) of Startec Global Operating Company Previously Held by Startec Global Communications Corporation and Startec, Inc.

Dear Ms. Dortch:

On behalf of Startec Global Operating Company ("Startec") and pursuant to discussions with staff, this letter requests that the Commission update the name of the holder of the international Section 214 authorizations granted in IB File Nos. ITC-89-099 and ITC-214-19970627-00354 (old File No. ITC-97-379) (the "Authorizations") to reflect Startec as the holder. As described in footnote 2 to the Application of Startec Global Communications Corporation ("SGCC"), Startec, and Platinum Equity, LLC filed in IB File No. ITC-T/C-20070328-00124 (the "Application"), the Authorizations were originally issued to Startec, Inc. and through various *pro forma* transactions were assigned to SGCC, *see* IB File No. ITC-97-579-TC, Report No. I-8266, and Startec Global Licensing Company, *see* ITC-98-607-TC, DA-98-1657. Ultimately, the Authorizations were assigned to SGCC's subsidiary, Startec. As indicated in footnote 2 to the Application, Startec believes it informed the Commission of the *pro forma* assignment of the Authorizations to Startec by letter dated June 14, 1999. Therefore, Startec requests that the Commission update its records to reflect that Startec holds the Authorizations.
