TDS Metrocom, LLC ("TDS"), by counsel and pursuant to MCL § 484.2313, respectfully submits this filing to the Michigan Public Service Commission (MPSC) of its intention to discontinue the provision of all voice and data services in Ann Arbor, Michigan beginning no sooner than ninety (90) days after the Federal Communications Commission's approval of its proposed discontinuance, or March 23, 2022, whichever is sooner. Exchanges in which the services will be discontinued include: Ann Arbor; Detroit Zone 5; Farmington; Livonia; Northville; Plymouth; Romulus; Southfield; Wayne; and Ypsilanti. The effect of this discontinuance upon the Michigan competitive telecommunications market will be minimal, as TDS currently provides residential voice and data services to 273 customers in the affected area, and approximately 595 commercial customers in the affected area, and these customers have a growing number of alternative choices for service providers. A list of alternative providers appears at the end of this filing. Additionally, approximately 593 of the 595 commercial customers within the affected area will continue to receive service through TDS using an analog terminal adapter which will allow TDS to provide voice (VoIP) service to customers over broadband connection purchased from another provider. TDS does not intend to surrender its license, as it continues to provide services affected by this discontinuance to other geographic regions.

Consistent with the MPSC's discontinuance requirements as set forth in MCL § 484.2313(5), TDS is providing this notice concurrent with its Federal Communications Commission



(FCC) Section 63.71 discontinuance petition filing<sup>1</sup> and the issuance of initial notice to affected customers. TDS has also notified all interconnecting Michigan telecommunications providers, including: Wiltel (Verizon); MCI (Verizon); Sprint Spectrum; and Level 3 on behalf of Sprint PCS.<sup>2</sup> Arrangements have been made for notice of the proposed discontinuance to be published this week in the Spinal Column, Southfield Sun, Ann Arbor News, Detroit Jewish News, Plymouth Observer, Northville Record, Livonia Observer, Farmington Observer, Farmington Press, Detroit Free Press and Detroit News.<sup>3</sup> Following receipt of FCC approval, and no less than ninety (90) days before discontinuing service, TDS will provide second notices to the MPSC and affected customers, and will arrange for a second publication in the Spinal Column, Southfield Sun, Ann Arbor News, Plymouth Observer, Northville Record, Livonia Observer, Farmington Press, Detroit Jewish News, Plymouth Observer, Farmington Press, Detroit Free Press and Detroit News, TDS will provide second notices to the MPSC and affected customers, and will arrange for a second publication in the Spinal Column, Southfield Sun, Ann Arbor News, Detroit Jewish News, Plymouth Observer, Northville Record, Livonia Observer, Farmington Observer, Farmington Press, Detroit Free Press and Detroit News.

### Discontinuance of Local Exchange Service in Ann Arbor, Michigan.

On November 2, 2000, the MPSC granted TDS authority to provide basic local exchange service in all exchanges then served by Ameritech Michigan in Case No. U-12554.

As of November 22, 2021, TDS has 273 residential customers and 595 commercial customers who are affected by the proposed discontinuance. The residential customers receive voice and DSL services, while the commercial customers receive analog voice, DSL, and T1 data services. After extensive assessment of the market, TDS has determined that its strategic business plans in Michigan do not include the continued provision of the basic local exchange services in Ann Arbor.

On November 22, 2021, TDS sent written notice by first-class mail to all affected customers in Michigan, notifying them that TDS will cease providing basic local exchange services they currently receive in accordance with state and federal law. A copy of the notice sent to Michigan residential subscribers is appended as **Attachment 4**, and commercial subscribers' notice is appended as **Attachment 5**. The notices comply with FCC Rule 63.71 and underscore to subscribers the need to make arrangements with another provider in a timely manner. A toll-free customer service number as well as an email address for TDS is provided so that subscribers may seek assistance from TDS personnel while making these arrangements. Consistent with the MPSC's discontinuance procedures, the notices also make

Comments should include specific information about the impact of this proposed discontinuance (or reduction or impairment) upon you or your company, including any inability to acquire reasonable substitute service.

You may request that the Michigan Public Service Commission investigate the availability of comparable voice service with reliable access to 911 and submit comments to the Michigan Public Service Commission via mail to the Executive Business Section, Michigan Public Service Commission, P.O.
